Financial Review

- Big payments from the landscape project
 - A little over budget ~\$42k all in
 - Approved to spend \$48k (July meeting), mounds to be another ~\$4k
 - Buying 6" drop mounds for each of the small fields
 - ~\$2k a piece
 - The mound on the turf field will move to the big field
- ~\$16.5k Checking, ~\$35k Savings
- Need to pay insurance, utilities, etc. yet this year
- Sponsors and tournaments will start coming in the end of this calendar year
- ~\$122k income for the year a little short of last year
 - o It should be discussed registration fees, etc. to make sure we do not start to drop money
- Reimbursement from bounce house company

Gun Raffle Sale

- Andy Adams has been out of town, so he hasn't gotten to sharing the items to the board
 - o Dave Bauer will help get this completed by next meeting

Tournaments

- 13U Team
 - Might not have enough for 13U now
 - Wait to publish 13U for that weekend, but will post 14U
 - Matt S considering stepping down as coach (13U)
- City League Tournament
 - o June 24-28th, 2024
 - o Family Fun Day would be Saturday, June 29th, 2024
- 9U 12U Tournament
 - o Currently potentially have teams at 10U and 11U will add these to the July 20th weekend tournament
 - o If there isn't an 11U, then they could go up to 12U so there will be a team, but we need to know what team we post to the tournament
 - Tom McCarty is at his two-year term and we must open up head coach position this year
 - o Brandon Schreiner to review 9U email and determine if sender received enough interest for a 9U team
 - Ideally want to have 12 players to cover players who quit, can't make it, etc.
 - Brian Zell to look into posting an ad at the school to determine interest (not an official signup)
 - If we don't have a second home tournament, we will have to adjust the registration fees
 - ~\$200 a player if no home tournament we provide 3 tournaments at this rate
 - Can do more, but would have to ask parents or raise money for the additional tournaments
- MYB will 10U, 11U, 14U for July 20th weekend tournament
 - We will determine path after registration if the number of players is not what we thought

Open Enrollment

- We've discussed allowing open enrollment and drafted updates to the Bylaws
- We need to determine rules around this so MYB follows its values
- Would this affect our Non-Profit Organization (NPO) status?

All Star Team

- Should we start a Little League All Star Team?
- Would not be competing against club then
- Insurance was quite expensive for this
 - Would have to plan for some additional fee structure for this
 - Would have to pass this fee onto entire league and only 12 players would make it per level
- Additional rules to consider to get into this
- ~\$63 per player to afford this

 - Would like to add consequences
 - New Article XVII Little League All Star
 - It was mentioned we did this in the past and sounded like something we might want to do again
 - We need more information around this, and would like to have it in the Bylaws incase it is chosen to do for the season
 - Should add section on if Non-For-Profit (NPF) would be resolved
 - Jim Cveykus to add this section for next meeting
