- 1. The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular skills, equipment, and personal discipline may reduce the risk, the risk of serious injury does exist; and,
- 2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES, or others, and assume full responsibility for my participation; and,
- 3. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such hazard to the attention of the Local League immediately; and,
- 4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFIY, AND HOLD HARMLESS MSBL/MABL, INC., CHESAPEAKE MSBL, INC., their Officers, Board of Directors, Officials, Agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, volunteers and if applicable, owners and lessors of premises used for the activities ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property associated with my presence or participation, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

Player's Participation in National and Local MSBL Leagues

The Player shall participate in the National League as a member on a team called __________, which is a team participating in Chesapeake MSBL Practices/Regular Season/Post-Season/All Star /Co-Ed/Labor Day and Columbus Day Regional and National Tournament Game(s). As a member of the League, the Player shall be eligible to participate in MSBL Tournaments, as organized by the MSBL National and Local League, according to the regulations promulgated by the MSBL National and Local League. The Player recognizes, as a member of this organization, the authority of the President, Officers, Tournament Director, and the Board of Directors to determine and enforce organizational policy. The Player agrees to abide by all Rules and Regulations as set forth by the League President and the Board of Directors. Failure to abide by all Rules and Regulations could result in suspension or expulsion and possible forfeit of all games in which Rules and Regulations were not abided by. I understand I am required to pay a player fee as determined by the manager of the team listed above in the amount of \$______. I acknowledge and understand that this fee is non-refundable. I further acknowledge and understand that there is no guaranteed playing time on any given team associated with practices, regular season, post season, all-star, Co-Ed, and regional or national tournament play.

- I will observe all rules as established by the MSBL/MABL, Inc. and Chesapeake MSBL, Inc.
- I understand that fighting, physical and verbal abuse of players, umpires, or spectators, and the use of offensive language will not be tolerated by the MSBL/MABL, Inc. and Chesapeake MSBL, Inc. and violation of this rule could result in permanent banishment or suspension from practice, regular season, post season, all-star, co-ed, and regional and national tournament games.
- I understand that MSBL/MABL, Inc. and Chesapeake MSBL, Inc. do NOT possess a defibrillator.
- I understand that I must turn the minimum age allowed for division play on or before December 31st of current year.
- I understand that neither medical insurance nor liability insurance is inherent with local league/national membership.

I have read this release of liability and assumption of risk agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without inducement and understand it is binding upon me, my heirs, spouse in interest and assigns.
