The meeting of the Massachusetts Hockey Board of Directors was held on Monday, October 7th, 2022, remotely via zoom.

Meeting called to order by Bob Joyce at 7:02 PM and welcomed everyone in person.

1. President's Opening Remarks

Bob Joyce welcomed everyone to the meeting.

2. USA Hockey IT Update

Peter Giuliano: Still having issues with updates from safesport and CEPs updating in the portal for rosters.

Bob Joyce: There were also issues with the referee reporting system but that appears to be resolved now.

Chris Mayer: Why haven't we received notice from USAH regarding the communication issues.
