From the February 1st AHAI Board meeting,

- AHAI passed extending the fall season roster dates to April 30 2021.
- The AHAI Board of Directors also have rescinded a vote to extend the Regular (Fall) Season for the 2020/21 Season to April 30th through an AHAI approved Electronic vote.
- The following AHAI rule amendment for just the 2021/21 season was passed by electronic vote:
- Approved Rule- The AHAI Board of Directors will consider requests to add a
 player registered with USAH for the 2020/21 season who is not currently on
 any other 2020/21 Regular (Fall) season Official USAH Certified Roster
 provided there is an open roster spot without removal of a player and the
 team is not National Bound (as designated in the USAH Registry Portal when
 the roster was approved). Petitions for this exception must be received by the
 AHAI registrar by 5PM February 28, 2021.
- Amendment being requested- ADD Seniors only can be added to HS teams (including Girls HS teams) regardless if they are currently on another 2020/21 Regular Season Roster provided there is an open roster spot without removal of a player. Petitions to add seniors to a HS roster must be received by February 28, 2021. This is only for the 2020/21 Regular Fall Season which ends March 31, 2021.
- Presidents were sent an email restating the regular and spring season roster dates and an explanation of USAH non sanctioned guidelines
- AHAI Registrar presented the 2020/21 registration information to the BOD
- It was discussed that a long range strategic plan is needed to retain, increase membership and provide Leadership to the membership
