Gambling Update:

Jim Marcotte discussed the budget and actual results of each gambling site during the month of April, 2023. A motion was made by Neil Huewe and seconded by Eric Carlson to approve the LG1004's as presented. Motion carried.

Jim Marcotte also suggested to the Board that the salary for John Hunt increase from \$100 to \$150, considering the additional sites we have added since he was hired to help Jim with site inventory. A motion was made by Troy Strassburg and seconded by Brent Magnuson to approve the increase in salary to \$150. Motion carried.

There were two additional topics brought up at the meeting by Jim Marcotte for first discussion, but action will be tabled until next month. The topics were as follows:

- Jim would like the Board to consider a membership with Allied Charities of Minnesota, which is a lobbyist group that advocates for charitable gambling in Minnesota. The cost of membership is \$300 per year and includes a subscription to the organization's newsletter, legislation updates, the support of the lobbyist to advocate on behalf of charitable gambling, and a discount to the annual lawful gambling conference.
- Jim is working on a proposal for a Gambling Assistant. Jim has a candidate in mind but will formalize a proposal prior to next month's meeting.

Consent Agenda:

Previous Minutes:

A motion was made by Jenn Nelson and seconded by Brent Magnuson to approve the minutes from the April 12, 2023 Board Meeting as presented. The motion carried.

Checks and Financial Reports:

The April 2023 financial packet was reviewed and discussed. A motion was made by Amy Haskell and seconded by Casey Reierson to approve the checks and financial reporting. The motion carried.

HDC Report:

The HDC representatives present provided updates to the Board. The following were some of the notable topics:

- September and October hockey schedules will attempt to improve coordination this year around fall sports
- Skill Sessions will return in the 2023-2024 season, although some levels may be combined; for instance, may want to run position-specific sessions for PeeWees and Bantams, and also have separate goalie sessions.
- The coaching meeting for the 2023-2024 season will occur early in the season for everyone even slightly interested in coaching. Also considering mid-term evaluations for coaches.

Old Business:

- <u>Board Reps for Committees</u> finalized assignments are noted on the attached Committee Reports document.
- <u>Concessions</u> Mitch Hill would like to speak to the Board about the 2023-2024 season.
 Action: Add Mitch Hill to the June Agenda to report on last season and discuss contract for new season.

New Business:

• <u>218 Sports</u> – Corey Rupp and Tracy Pogue, along with intern Chloe Lund, came to provide an update on the progress of 218 Sports. This group is a non-profit with the mission of economic development in Bemidji through sports. The organization came to





ask the Board (out of respect; no motion required) about logistics of 218 Sports running some tournaments in the future. The Board indicated support.

- <u>Budget for upcoming fiscal year</u> Treasurer Becky Adams provided a summary of the proposed changes to the budget. The primary changes and general comments comparing the budget from last fiscal year to this upcoming fiscal year were summarized as follows:
 - Decrease in anticipated revenue from tournaments
 - Putting more money into equipment needs (goalie; on-ice equip)
 - o Retain dollars for ice rental at Sanford Center (tournament championships, etc.)
 - o Increased line item for special sessions, such as power skating
 - Hold salary for Hockey Director (this has been in the budget the past couple years as well)
 - o Dropped revenue estimate for Spring Ice; lower registrations this past year
 - Still a balanced budget!
 - BCAC use fee increased 5%; but BCAC is a non-profit so "extra" for them can benefit us

There was additional discussion on registration fees and the need to increase fees. It was determined that this budget can be approved without detailing registration fees at the same time. A motion to approve the budget as presented was made by Travis Reierson, seconded by Brent Magnuson. The motion carried.

Action: Add Registration Fees to the June Agenda
