# • Finance/Budget

- > \$240K cash on hand; looking good; much better position than last year, will re-seed two (2) CDs this spring; we had to tap those funds this season due to tournament fees, ice and District 2 payments in early 2019; total to put back \$100K; looking to put 50K away, maybe 100K.
- > \$60K in outstanding bills; currently good on ice budget.
- ➤ Mite/U6/U8 Jamboree's; fixed costs; pay expenses on card for each Level Director.

#### E-Mail Blasts

Continue to coordinate with everyone on e-mail blasts. Board members provide the content and I will edit/format and send out.

### • Team/Individual Pictures (Lifetouch)

- > Team/Individual pictures were delivered/picked up by all team managers two (2) weeks ago and distributed to players; mostly positive feedback on how they turned out.
  - ➤ JG18's did not make the Dec. 21<sup>st</sup> picture date outside at the DEC; they advised Ann Macdonald, Picture Coordinator they did not want to reschedule with Lifetouch; advised they would take their own picture.
  - Panoramic pictures have been delayed due to me; did not approve any of them; they were poorly done; worked with Lifetouch photographers/graphic designers to revise the background; modify the overall layout and sizing of players etc.; final approval was done by each team manager; went to print last week; should be ready this week.
  - ➤ Banners needed some corrections/modification as well; did get the 50<sup>th</sup> Year logo on both banners and the Pano's; banners are being sent this week.
  - Determine if we move the picture date back to October next season or keep it outside in December; picture delivery is this time of year if we stick with a December date; some complaints on getting pictures this late in the season.
