Much of the concern revolves around unknown or misunderstood conceptions. Scott has been in discussions with Parks and Rec, and has worked with Chris on a letter in respose to cencerns expressed so far (i.e: traffic, noise, lighting etc). Overall use will be less than current levels.
