Rule Change

CURRENT RULE

1.5.3.1 A limit of twenty (20) players at any one time may be registered per team except for High School, College and Women's College who may roster thirty (30) players and may play twenty (20) players, and Junior, Adult and Women's teams who may roster twenty-five (25)players and may play twenty (20) players. A player may be registered in only one (1) National Ice Hockey Federation. (Note: It is recommended that a team consist of a minimum of at least fourteen (14) players).

PROPOSED RULE

- 1.5.3.1 A limit of twenty (20) players at any one time may be registered per team except for High School, College and Women's College who may roster thirty (30) players and may play twenty (20) players, and Junior, Adult and Women's teams who may roster twenty-five (25)players and may play twenty (20) players. A player may be registered in only one (1) National Ice Hockey Federation. A team must consist of as minimum of at least twelve (12) players including goaltenders. Exceptions to this rule may be considered by the respective Committee Chair
