Proceedings

Meeting called to order by Ben Goodman at 7:30pm. A motion was made by Michelle Goodman, to approve the April 10, 2023 board meeting minutes. Erin Hanson seconded the motion, with no board members opposed.

Program Updates

The Board received the following updates:

1. In-house Update - Madden

- Had the final SSYBL meeting of the year yesterday evening. We discussed some rule changes/rule clarity.
- We are looking at keeping the same schedule for SSYBL games and tournament as last year. Families liked having the end of the year tournament over 2 weekends.
- There was some discussion about having more formal uniform with all associations have matching shorts and jerseys. Currently we supply the jerseys but players can just wearing whatever shorts they want. I personally prefer players providing their own shorts. #1 it keeps expenses down on our end. #2 it allows players to wear shorts they feel comfortable in.
- I am planning on having In-House registration stay the same. Open in summer and end on September 30th. Gives me time to order shirts, get gyms ready, teams for younger grades.
- I read over the survey results and it was interesting to hear the thoughts of the families who responded. Currently we have 6 Skill Sessions for SSYBL teams (grades 3-6) and then the season starts in January. Teams are formed in mid-December. With the holiday break that means teams get 1 practice with their team before the first game. I like the idea of shortening the skill sessions to 4 weeks and adding 2 more practices for individual teams. That would mean more gym scheduling so I would have to see if In-House has the gym space.

• I talked to a representative from the Timberwolves about an In-House outreach program they are starting (see attached). It would cost us a little upfront (would either have to build the cost into registration, EVBA cover the cost or split it between). Not sure what I feel about it; would be a fun experience but it would cost some money. Not sure if families would even be interested in it.

2. Fundraising – Hanson

- Working with Hope on dates for our kick off event
- Signs to be placed with coaches names so parents can locate them more easily
- 2 courts at Hope instead of one
- Utilize EVHS players for rebounders for shooting games!

3. Player Development Update – Sikich

• Shot Club starts on June 4th – announcement going out week of 5/22 – Rachel and Scottie

4. Year End survey results – M. Goodman

- 104 families filled it out, 47 inhouse families and 57 travel families
- Lots of positive feedback in house families loved the SSYBL end of year tournament!!
- One area of concern that was consistent was sharing gym space was not ideal as well as the issues with Hope and Bethel Rock. Which we know about and have plans for next year to hopefully avoid.
- Travel parents would also like overnight tournaments to come back. Girls side is researching this (Rachel!!!) and I think the boy's side is too??
- Average rating of 8.9/10

5. Other items:

- Year End Financial results
 - financial update after I receive April's final numbers. We should finish somewhere around \$40,000 in the black. We had one leftover boys tournament invoice from Burnsville 191 and that was just paid. Aside from that all other coach and In House invoices should be all paid.
 - I am in favor of trying to get back to 10 tournaments and maintaining the current registration fees or having a small/modest increase of \$25 or less. My final opinion would depend on Brad and Michelle's thoughts on number of teams next year vs this year. Don't want to set ourselves up to be short, but if we feel like we can hit the same revenue next year as we did this year I'm confident we can take on the extra tourney/ registrations and still have a profitable year.
- Outstanding DIBS still finalizing. Jude to work with Joann on the remaining.
- Traveling Tournament Planning Reciprocity with other associations discuss next meeting
- Girls Tournament potentially adding a 3rd grade division.
- Bylaws Refresh to be voted on next month Sue, Ben and Jude to connect
- Max number of teams by grade: voted and approved by all members to keep a maximum of three 8th grade teams per gender.
- New board positions see addendum voted and approved by all members
- Coaches clinic wrap in MSOB and partner with EVHS next year to provide opportunity for all coaches.
- Ideas for continued alliance with EVHS programs Brad meeting with Danny this month and will provide updates next month.
