RELEASE OF LIABILITY, WAIVER OF CLAIMS AND ARBITRATION AGREEMENT				
<b>NOTICE – By signing this document you may be waiving certain legal rights, including the right to sue.</b>				
<b><u>Release and Waiver of Claims</u></b>				
In Consideration of being allowed to participate in the 40 Hour Hockey School ("The Program") and Ice Hockey at the Enfield Twin Rinks, LLC (the "Facility"), the Participant, and the Participant's parent(s) or legal guardian(s) if the participant is a minor, do hereby agree to the fullest extent permitted by law, as follows:				
1) TO WAIVE ALL CLAIMS that they have or may have against the "Program" or the "Facility" arising out of the inherent risks of engaging in Ice Hockey 2) TO ASSUME ALL RISKS INHERENT IN Ice Hockey; and 3) TO RELEASE the "Program", "Facility," its owners, affiliates, officers, directors, employees, agents and shareholders, GD Alumni Group, LLC, its officers, owners, directors, employees, agents, and Christopher Shuman and the staff of the 40 Hour Hockey School from all liability for any loss, damage, injury or expense that the participant (or his/her next of kin) may suffer, arising out of the inherent risks of participation in Ice Hockey.				
<b><u>Arbitration</u></b>				
The participant hereby agrees to submit any dispute arising from participation in Ice Hockey to arbitration, for the sole purpose of determining whether the alleged injury arises from a risk inherent in the activities engaged in by the participant. For such disputes, there shall be a three-member arbitration panel, consisting of two party-appointed arbitrators (one arbitrator to be appointed by each party) and one neutral arbitrator (collectively, the "Panel"), to be chosen by the party-appointed arbitrators. In the event that the two party-appointed arbitrators are not able to agree on a third neutral arbitrator, the neutral arbitrator shall be appointed by the United States District Court, for the District of Connecticut. Each party shall pay its own costs, including the costs associated with the neutral arbitrator. The arbitration proceedings shall proceed in Hartford, Connecticut, and shall be governed by the Federal Rules of Evidence. The "Panel" shall establish a reasonable and appropriate discovery schedule to expeditiously resolve this matter. In the event that the "Panel" determines the alleged injury arises from a risk inherent in the Participants participation in Ice Hockey, the claim shall be deemed barred, as a matter of law and the participant shall be barred from recovering any compensation from the "Program", the "Facility", GD Alumni Group, LLC and Christopher Shuman, Armand Latulippe, Robert Hanke and Keith Hillebrecht, individually. In the event the "Panel" determines the alleged injury did not arise from a risk inherent in the Ice Hockey Event, the Participant shall proceed to the Superior Court of Connecticut, or if appropriate, the United States District Court for Connecticut, for a trial <i>de novo</i> .
