I acknowledge, that by declaring this team a Southeastern District and National Tournament Bound team, the team is obligated to participate in the Southeastern District (SED) Tournament in the Spring of 2026 if the team is selected to advance from PVAHA to the SED Tournament.

I understand that girls participating on a team playing in the SED Tournament or any USA Hockey National Championship will likely be required to miss time from school to participate in these tournaments. I acknowledge that the team will play in the USA Hockey National Championship if it wins the Southeastern District Tournament.

I understand that the team will be required to play 14 games and that each player on the team will be required to play 10 games for the team before the PVAHA Tier II Girls' Playoffs. The team manager shall contact the USA Hockey State Registrar to arrange for a review of all credentials to be conducted no later than Wednesday prior to the start of the playoffs. Players who do not make their game count will be unable to participate in any Affiliate or District Tournament or USA Hockey National Championship.

I understand that my team(s) will be responsible to pay a tournament fee as set forth each year in the *Southeastern District Tournament Handbook*.

I understand that my team(s) will be responsible to pay a \$1,500 fee payable to PVAHA and sent to: PVAHA Treasurer, 16012 Gary Avenue, Chester, VA 23831 by September 15, 2025. I understand that my team may be sanctioned under PVAHA rules if it refuses to participate in any PVAHA, Southeastern District or USA Hockey National Championship. Further sanctions may be imposed by PVAHA and Southeastern District:

In the event a qualified team withdraws from either the PVAHA playoff weekend and/or the District tournament after the ice commitment, and a replacement team is not selected, the withdrawing team shall pay the full playoff and/or tournament fee(s) to the Host Affiliate, a penalty of up to \$3,000 to the Southeastern District and shall be referred to PVAHA for discipline.

- ▶ **PVAHA Tier II Girls' Playoffs**.....February 6–8, 2025 (*hosted by PVAHA @ The Gardens Ice House*)
- ▶ **SED Tournament**.....March 6–8, 2025 (*hosted by CAHA*)
- ▶ **Girls' Tier I Nationals**.....March 24–29, 2026 in Amherst NY
- ▶ **Girls' Tier II Nationals**March 25–29, 2026: 14U in Rochester, MI; 16U in Maryland Heights, MO; and 19U in Rockland, MA
