President Report -

Follow-Up from Previous Meeting-

Spring Try Outs Update:

Squirts: 50+ Squirts for try outs; potentially 5 teams total (1 non-snow belt & 3-4 snowbelt); potentially 7 squirt goalies; Independent Team selected 13 players & 1 goalie (1 player did not commit, so going into fall there is currently 12 players & 1 goalie)

- o Girls 12U: 14/15 players tried out; 10 players committed
- o Girls 14U:try outs April 22nd,23rd,29th and May 3rd
- 12U Co-Ed: 8 players have committed of the 12 total letters of commitment that were sent out; 16 players attended try outs; 2019/2020 season will be a non state bound red snow belt team. There are 23 12U aged players currently minus girls.
- Board Restructuring: Nate will redistribute plan/idea for new RYHA board structure to then be discussed at the May meeting.

New Business:

Central Section Meeting:

- Referee Seminars will be held in July, Aug, & Sept. The Utica/Rome area currently has lower referee numbers due to lack of recruiting in our area.
- Per Jason Combs- scheduling with Mary has been an issue with placing referees in nonlocal areas making it difficult for referee availability.
- Safe Sport: there will be new legislation with the National Sports Boards 2020/2021 which will include a new National Screening process-the cost of the change is currently unknown
 - 2019/2020 Safe Sport will require annual training and additional trainings after initial training.
 - Players 17 years+ will have to go through annual Safe Sport trainings
 - Potentially anyone affiliated with the sports program will have to be Safe Sport certified (concerns/questions arose regarding JFK Arena staff/employees)
- Motion was voted down regarding game period reduction at 14U & older levels because of the reduced ice surface
- Handshake proposal of shaking hands prior to the game rather than after was voted down.
- Gary LeBrun proposal: 15U, 16U, 17U showcase teams of non-high school players that were on a tournament bound team- idea came from the increased amount of misconduct/fighting that stems from skilled players playing at a lower, snow belt league instead of playing on a more competitive tournament team.
- NYS Amateur Hockey Association annual meeting is Saturday, June 1st at 9:00 am in Syracuse at the Downtown Marriott-needs volunteers to help at meeting
- o Coaching Certifications deadline will be August 1st for tournament bound teams.
- Tier 2 to Tier 3 requests: Whitestown requested to move to Tier 3 for the 2019/2020 season
- Recruiting discussions and pre-try out skates

Referee Sponsorship Program:

- Level 1 referee clinic costs \$35- association offers to play for 10 level 1 referee clinics for brand new potential referees
- Motion by Darcy Crofford, second by Crystal Graves- motion carries

Jerseys:

- Phase in approach with new jerseys for mites and squirts for the 2019/2020 season
- Allow PeeWee and Bantam players to use current jersey
- Squad Locker does allow jersey orders
- Board will make decision at the May meeting
- Jersey Coordination will be done by Beth and Jen

Tier 2 vs. Tier 3/Long Term Plan for RYHA:

- Long term goal for RYHA: potentially see pressure from central section to move to Tier
 3.
- RYHA needs to consider strategy of being a regional Tier 2 association for travel team level teams-field birth year teams at every birth year possible under at new team name and logo to be hopefully ready to share with RYHA board at May meeting.
 - Ideally partner with local associations at the Tier 2 level such as New Hartford, Clinton, Rome, & Whitestown.
 - Birth year travel teams will maintain policy not to accept snowbelt players onto travel teams
- o Rome Grizzlies will maintain house team at snow belt
