

COVID-19 ACKNOWLEDGEMENT FORM

WASHINGTON TOWNSHIP and the WASHINGTON TOWNSHIP Department of Recreation (“TOWNSHIP”) offer to the public the option to participate in, or attend, various physical, social and/or educational programs/activities (“Recreation Program(s)”) held on WASHINGTON TOWNSHIP property.

Due to the ongoing COVID-19 pandemic, individuals age 18 or older seeking to either enroll themselves, their child and/or other dependent family member into any of the TOWNSHIP’S Recreation Programs, or to volunteer or otherwise participate in any Recreation Program(s), must complete, sign and return this Acknowledgment Form to the RECREATION DIRECTOR by the Recreation Program enrollment deadline. Enrollment and/or participation in any Recreation Program is conditioned upon timely completion and submittal of this Acknowledgment Form.

ACKNOWLEDGEMENT

By signing this Acknowledgement Form in the space provided below, I, my child and/or other dependent family member(s) do/does hereby acknowledge, understand and agree as to the following:

- (1) I/WE have read and fully understand this Acknowledgment Form; the Center for Disease Control’s (“CDC”) and the New Jersey Department of Health’s (“NJDOH”) information and guidelines regarding the SARS-CoV-2 virus and COVID-19 (the disease caused by SARS-CoV-2), including steps that can be taken to prevent the spread of SARS-CoV-2/COVID-19, and the WASHINGTON TOWNSHIP Department of Recreation’s “COVID-19 Operational Plan” for 2022;
- (2) SARS-CoV-2/COVID-19, is a highly contagious respiratory virus/disease, and can cause serious illness and permanent bodily injury, including death, to persons of all ages;
- (3) SARS-CoV-2/COVID-19 remains prevalent throughout New Jersey, and spreads by droplets produced into the air when an infected person coughs, sneezes, talks, breathes air out through their nose and mouth, or from touching surfaces which contain droplets of SARS-CoV-2; and that a person can contract COVID-19 from being in direct contact with, or in close proximity to (within about 6 feet or less) an infected person; and
- (4) That attending or participating in a Recreation Program poses an inherent and heightened risk of exposure, to SARS-CoV-2/ COVID-19 regardless of preventative measures taken by the TOWNSHIP.
- (5) I/WE shall observe and abide by the TOWNSHIP Department of Recreation’s COVID-19 Operational Plan on preventing/limiting the risk of exposure/spread of COVID-19.
