My name is Bill Page and I am the Rink Manager at Churchill Rink at Jackson's Landing.

Like many town owned facilities of its type, Churchill Rink is classified as an Special Revenue Fund under Durham's municipal structure. The single most important requirement for us is that all expenses to operate the facility must be paid for with revenue generated at the facility. (No taxpayer dollars.) All of our operating costs are covered with revenue from facility rental fees, public session admission, concessions, skate sharpening fees, and advertising.

Although the opportunity has always existed, in years past there's been little effort to promote the benefits of advertising here at the rink to local businesses. The customers here daily are a captive audience and exposing them to your business has never been easier. On that note, I want to introduce you to our new advertising program. 

FILE RESOLUTION
