Tom Berry: Financial

Amanda Gobert: Registrar

Things are running pretty smooth. Amanda is a bit disappointed that registrars did not check their coach status before the end of the season and panicked to get coaches on the rosters at the last minute.

If a coach is having an issue with background or safesport not showing up as completed, that coach needs to contact Rick Frescura, NOT their local registrar, not Amanda, not USAH, Rick Frescura.

Next season-let's make sure registrar's know to direct coaches and managers to Rick Frescura, not to Amanda.
