- Invited Tony S. to discuss Park & Rec
 - Shut down currently, handling parent questions regarding fees/reimbursements for first session of the season,
- Report on COVID Executive order to pause through Dec. 18, OYHA has had 45 players and coaches having to quarantine thus far this season (approx.. 25% of total), MN Hockey pushing to allow one team practice per ice session but unlikely, Executive order means all in-person team events must pause (i.e. no organized outdoor practice), Need to find ways to connect virtually, Financial impact due to suspension of gaming and concessions, Need to game plan for how to handle requests for refunds,
- Attended Steele County Board meeting to discuss sign fundraising, offered 10% to the County instead
 of current 40% with the support of the Blades. 10% proposal was rejected and OYHA has decided to
 step away, instead asking for direct monetary donations from businesses in support of youth hockey.
