### 2018-2019 Parent/Player Contract Agreement

#### **Section I: Conditions of Participation**

(I) We the parent(s)/guardian(s) (hereafter referred to as the "Responsible Adult") of

\_\_\_\_\_ (hereafter referred to as the "Player") have read the **USA Volleyball Great Lakes Region Parent/Guardian document** (located on the Net Force Volleyball Club website) along with the **Player/Parent/Coach Handbook** (located on the Net Force Volleyball Club website) concerning the policies and procedures with regard to practices and competitions of Net Force Volleyball Club, Inc. (hereafter referred to as the "Club"). We agree, having been selected to a team, to allow the Player to join the Club for the 2018-2019 season.

We understand that we are responsible for all dues and travel fees for the Player and (I) we will provide transportation for the Player to and from all practices and tournaments for the duration of the 2018-2019 season.

We have read the materials provided and understand the significant time commitment involved in practice and competition. We have reviewed the fee schedule and dues (located on the Net Force Volleyball Club website) and understand that all fees must be paid in full regardless of the duration of Player's participation and on-court time during tournaments. This is because membership in the Club is limited and others were denied participation by the Player's acceptance of a position within the Club. As the Responsible Adult I acknowledge that withdrawing from the Club prior to the last payment date of the current season does not absolve me from payment of all scheduled dues payments, expenses and/or other Club functions that the Club has committed to on the Player's behalf.

Understanding these stipulations and having discussed these with the Player, we agree to and will support her participation in the Club. We understand that once registered with and having competed with the Club, the Player is unable to transfer to another club and is committed to this Club until the end of August 2019.

#### **Section II: Membership Dues and Fees**

The undersigned Player and Responsible Adult agree to accept membership in the Club for the 2018-2019 season. Membership entitles the Player to participate in practice/training sessions and tournament competition as designated by the Club. Equal opportunities to participate will be provided during practices, however, on-court time during tournaments is not guaranteed, but to be determined by the coaching staff and/or club director.

The total annual membership dues include: gym rental, USA and AAU fees and dues, uniforms, tournament fees, coaches' salaries, administration fees, equipment, medical supplies, postage, office supplies, coaching certification and training, and insurance. The listed price is an all inclusive price. There are no additional travel charges or uniform fees to pay. Players ordering additional team sportswear incur additional charges.

### 2017-2018 Parent/Player Contract Agreement

#### **Section III: Participation and Liability**

By use of the facilities provided by the Club, including the facilities at which tournament competition is conducted (collectively referred to as the "Facilities") the Responsible Adult expressly agrees that the Club shall not be liable for any damages arising from personal injuries sustained by the Player in, on or about the Facilities and further agrees the Club shall not be liable for any loss or theft of personal property. The Responsible Adult and Player assume full responsibility for injuries, damages or losses which may occur to the Player in or about the Facilities and does hereby full and forever release and discharge the Club, directors, owners, coaches, employees and agents from any and all claims, demands, damages, rights of action or causes of action, present or future, whether the same be known or unknown, anticipated or unanticipated, resulting from or arising out of the Player's use or intended use of the Facilities or equipment thereof; provided, however, that nothing herein contained shall release or discharge the Club from the willful and wanton actor or omissions of the Club, its officers or employees.

The Responsible Adult warrants, represents and agrees that the Player is in good physical condition and has no disability, impairment or ailment that prevents them from engaging in active or passive exercise that will be detrimental to her health and safety, comfort or physical condition if she does so engage or participate. It is recommended the Player consult their own physician before beginning any exercise program. The Responsible Adult and Player shall not be relieved of their obligation to make all payments herein agreed to and no deduction or allowance from said payments shall be made by reason of the absence or withdrawal of the Player from membership or by reason of the Player's failure to attend or use the Facilities.

The Responsible Adult and Player have received, have read, understand and agree to abide by and cause family members and guest to abide by the rules and regulations of the Club as they now exist and as they may from time to time be amended or supplemented.

The laws of the State of Illinois will govern this agreement, together with any attachment (s) and supersedes all prior oral or written representations or communications between parties. This agreement constitutes the entire understanding of the parties regarding the subject matter and may only be modified or amended by a written supplement signed by both parties.

This agreement is not assignable or transferable by the Player without the specific agreement and approval of the Club in writing. Because damages under this agreement are difficult to ascertain, the parties mutually agree that in the event of a default the Club is entitled to receive the entire contract balance plus any/all attorney fees, courts costs or other costs of collection incurred by the Club.

By signing this contract the Responsible Adult and Player give permission to the Club to use their photographs, video images, names and likeness for advertisement and promotional media to promote the Club.
