Discussed the latest information from USA Hockey Annual Congress meeting. Reviewed projected reduction of membership due to COVID projections. Discussed the new revised coaching program.

7. OFFICER'S REPORTS

♦ COACHING DIRECTOR – ROB KAUFMAN

The new CEP program pilot is very popular, sold out quickly. It was setup to allow documents to be shared during session, participants were focused. New program consists of an online zoom class to be followed up with a one (1) hour online with coaching director. Classes should be up and open end of July or August. All coaching levels need a yearly refresher. Level 4 need to do x amount of online education. Temporary cards issuing at current level for one (1) year but everyone needs to do it online of at all possible.

♦ GIRLS/WOMEN DIRECTOR— ANNA MARIE DION

- o 1400 girls /women registered, likely to see a dip this year in Wa due to COVID
- o 20 girls were selected to go to multi district camp which was cancelled, with 6 alternates, all camps were cancelled due to COVID
- Pacific District Tournament for Girls SJHA 16U TII 2nd, SJHA 14U TII 2nd
- o 1st Annual USAH Women/Girls Summit, 10 representatives, this was a great event and allowed for great connections
- 2021 Female Development camp will be January 29-31, 2021, location to be determined. Jim O'brien working on league or showcase option for girls.
- PNAHA league for girls 8U/10U, will do social media, Facebook, Posters, Try Hockey for Free Girls to promote event participation.
- All Associations need to help grow the game for girls, each association should have female rep and send that person's info to Anna-Marie

- o Referees will have a Zoom call of their own, taking things as it goes.
- Adult hockey has started up
- Discussion on electronic whistles and usage for the coming season, new process no handshakes.
