

**ADDENDUM OF KINGS YOUTH ICE HOCKEY ASSOCIATION TO DELAWARE  
VALLEY HOCKEY LEAGUE (DVHL) PLAYER / PARENT AGREEMENT**

This Addendum to the Delaware Valley Hockey League (DVHL) Player / Parent Agreement is entered into the Commonwealth of Pennsylvania between \_\_\_\_\_, born on \_\_\_\_\_ (the "Player") and jointly and severally by the Player's parent(s) and / or legal guardian(s) \_\_\_\_\_, residing at \_\_\_\_\_ (the "Parent") and the Kings Youth Ice Hockey Association, Inc. (the "Club").

Now, therefore, the Player, Parent and the Club hereby further agree to the following terms which amend and/or add to the DVHL Player/Parent Agreement.

1. The Player and Parent(s) expressly agree to abide by in all respects the USA Hockey Participant Code of Conduct, as it may be adopted and/or amended by USA Hockey from time to time and Organization Rules of the Club, as they may be adopted and/or amended by the Club from time to time.
2. The Parent (s) agree to abide by in all respects the DVHL Code of Conduct, as it may be adopted and/or amended by the DVHL from time to time.
3. In the event Player, Parent(s), and/or any non-signing parent or guardian of Player are charged or have been charged with a crime of moral turpitude, Parent (s) shall immediately notify the Club of such charge(s) and, in the sole discretion of the Club, the Player may be expelled from the Club in which event the DVHL Player/Parent Agreement and this Addendum shall be terminated. In the event of termination hereunder, Parent(s) or Player acknowledge and agree that all Player Fees paid to the Club shall be forfeited.
4. Parent(s) and the Player expressly acknowledge and agree that their completion of, and submission of, the DVHL Player/Parent Agreement, this Addendum, the Returning Player Registration Agreement, and any other form(s) incident to or accompanying the same, taken together constitute an offer by Player and Parent(s) for Player to participate in The Season and that no binding agreement exists between the Player and Parent(s) and the Club until the Club accepts the offer solely by execution of the DVHL Player/Parent Agreement, this Addendum, and any other required form(s) by a duly authorized representative of the Club.
5. I agree that I am now registering with the Kings Youth Ice Hockey Association to play for and be financially committed to the full payment as specified for the 2020-2021 season. All financial commitments must be fulfilled with the Club even if the player voluntarily resigns for any reason.

6. The Parent agrees that the Registration fee is non-refundable. Once the Player is placed on a team that fee is credited to the Player Fee. If the Player declines his/her position on a team, after the date designated by the Club, the Player will not be entitled to receive a refund of any funds paid and is still liable for any remaining season fees.

7. I understand that my child will be placed on a DVHL team as recommended by the coaching staff. Kings Youth Ice Hockey Association requires full player payments must be received by September 15, 2019. If Player Fees not paid in full by October 1, 2019, Player will not be permitted to participate in any Club-related activities on and off the ice.

8. By signing the contract Player/Parent agrees to be bound by AAHA Rule 17 regarding releases and appeals. All payment plans are to have a final date of September 15th - If not paid in full by February 1, Player's name is placed on the AAHA financial list and player cannot play for the rest of the season.
9. All defined terms in this Addendum shall have the same meaning as set forth in the DVHL Player / Parent Agreement unless specifically defined otherwise in this Addendum and to be bound by the terms of this Addendum and the DVHL Player/Parent Agreement simultaneously submitted.
