 - o For CMH Bear programs, it's the expectation that an AP will be used as needed to fill in practice slots or game slots as rostered skaters are not available.
 - o Brian's question is what's the definition of an affiliate player? If a player pays the full amount are they an affiliate or a full team member? More definitions required before adding this to the CMH handbook.

 - o Ryan believes the 4 & 5 year old numbers were low due to the CV19 rules
