# MASSACHUSETTS HOCKEY, INC. **BOARD MINUTES** February 7, 2023 - Zoom Meeting

The meeting of the Massachusetts Hockey Board of Directors was held on Tuesday, February 7, 2023, via zoom.

Meeting called to order by Bob Joyce at 7:01 PM and welcomed everyone in person.

### 1. President's Opening Remarks

Several of us attended USA Hockey Meetings in MLK Jr weekend. So far fairly quiet.

SafeSport. USOC came out with an interpretation that SafeSport coordinators cannot be USA Hockey Directors or Affiliate Directors. Christine Mayer has chosen to remain as USA Hockey Director and resigned as the SafeSport Coordinator for Massachusetts. We have engaged Scott Gray in a contractor role to support SafeSport. He is currently investigating 1 issue.

Program Services Coordinator, Mike DiOrio, has taken another position. After our recruiting efforts we received over 30 resumes of which we found some qualified candidates. We are soliciting answers to some questions to further review the applicants.

Discipline Tracking System. Gary Gates mentioned the committee is working through minor updates. They are looking for rule verbiage so that a report could be sent upon infractions. Biran Walsh thinks we are close to going live with this season's data as of 12/31/2022.

# Chris Holden:

- 1. Individual Registration Fees: Currently at \$368,555.50, which is 3% below where we were at the same time last season and 4.3% below last year's full season total.
- 2. Sponsorship Revenue: \$10,000 came in this month (\$5,000 from Jeff Serowik/Pro Ambitions and \$5,000 from Erik Kallio/Pro Stride Skating)
