For the lawful purposes requests below, the seconded motion was made by Cindy. All motions listed below were then approved:

For Baseball, Luke motions for up to 10K. Specifically,

• We would like to request \$10,000.00 to help our program. We need the funds to pay for field improvements that we have been putting off because we don't have the money for them. We also want to purchase new sweatshirts or jackets for the players for the spring season.

## For Basketball, Shanthi motions for up to 10K

- \*We will be hiring a trainer 10 nights per month for three hours each night for 2 months. The cost is \$86.00 per hour. The total amount that we will pay is \$5200.
- \*We are running our first basketball summer camp. We will need funds for gym space, trainers and providing shirts to children that attend then camp. We are seeking \$4800.

For Football, Casey motions for up to 10K. Specifically:

• Football is in need of donations, in the amount of \$10,000. We are planning a spring inventory at our storage unit and we anticipate having additional player and field equipment needs this year. Areas we need the money for are:

Shoulder Pads Helmets Field Lighting

For Volleyball, Molly motions for up to 12K. Specifically,

- Lakes Volleyball Club would like to request \$10,000 to help towards new volleyball standards.
- Our current standards are heavy, have multiple moving parts that wear easily and the ones we currently
- have at the Forest Lake Middle School are showing their age. We'd like to start replacing them as funds
- allow.
- We hope to purchase the Jaypro Carbon Ultralite 2-Court Volleyball System once funds are available and

- formal quotes are received from the company (we've made the request).

- Total estimated for one 3-cournt system = \$11,867.00

For Lacrosse, they motions for up to 10K. Specifically,

• The Youth Lacrosse Board would formally like to request \$10,000. We are proposing that we use the funds as follows:

$6,000 - new uniforms for all players
$2,000 - new equipment that FL Lax will retain but allow for players to utilize (balls, sticks, goalie gear)

\$1,000 - towards league fees for girls

\$1,000 - towards league fees for boys

For FLAFA, Melissa motioned for up to 10K. Specifically

• Our FLAFA Organization would like to request ten thousand dollars (\$10,000) in lawful purpose money to use for our organization. Currently, we have 153 players registered to play in our upcoming 2022 fastpitch season and as a board we would like to request this money to give all our players a warmup jacket to wear and use on and off the field. Many times, with the seasons changing from spring to summer, and summer to fall, some of the players wear a sweatshirt on the field of play and as a board we would like to see everyone have the same items to wear as a team. Hence, the warmup jackets as they will be wind and rain resistant, and the players can wear them during a game as they will match our uniforms. We are still accepting registrations so this number will likely increase as the season approaches. The jackets are \$65 dollars apiece and we would like to include all our players in receiving this pullover. Since our season has not started yet, I am sure we will take on another 10-30 kids before the season begins and I would like to see these players receive a jacket as well. Our player numbers last year were 170 registrations and if I up that number to 180 registrations for this year, that puts the cost of the warmup jackets at \$11,700. Any monies to help put forth this addition to our uniforms would be greatly appreciated!!
