### Spencer Family YMCA Ice Rink Guidelines

- Sneeze/Cough shields have been installed at front desk area
- Masks will be required for all who enter the building and must be worn at all times other than when on the ice.
- Each skater will need to submit the online COVID waiver to enter the facility. This waiver will be emailed out to all groups renting ice.- For younger skaters, 1 adult may enter with the player to assist with skates/equipment. We then ask all guests to leave the building once the skaters are dressed. No parents/guardians/guests are to remain in the building.
- Skaters will be allowed in 15 minutes prior to the ice session to get ready. To avoid congregating at the front doors please wait in your car until your entry time.
- Skaters should arrive fully dressed in their hockey equipment; showers will not be available after session.
- Skaters at the end of practice will have 15min. to get undressed and out of the building
- All Locker rooms will be marked with an "X" for 6ft social distancing
- Players must bring their own water bottle, filled and labeled with their names. Water fountains will not be available.
