Park & Recreation Report

- Still waiting on form the OMGAA Insurance form
- Waiting for snow to melt
- Highly doubt grass fields will be ready mid April- hockey arenas are ok, tennis courts to throw ball around, gym space, local private schools, parking lots. Anywhere, just stay off fields. Grass at parks is OK, just not on the fields.
- Typically, open fields 4/18 but this year, maybe end of April

Director Reports

Vice-President:

- Everything is booked at dome until closing which is April 16th
- Sent schedule to Junior Travel/Fastpitch for times available to teams
- Gleason scheduling meeting was held earlier this evening. Provided analysis of equitable
 allocation of fields. Next steps are to allocate leagues and fields to dates/times as a first pass
 before presenting to directors.

Training & Development:

- Clinics are completed
- Questionnaire ready to send out- satisfaction rates, feedback, ideas for next year
- There was a learning curve this year with consistency and who volunteered on Sunday
- Coaches Clinic with Peterson (April 16th penciled in), but also trying to get aligned with one of his practices and have him demonstrate how he runs practice.

Secretary:

Treasurer:

- Sent out profit/loss report to the board
- Good shape financially

President:

- Prime advertising Gleason Fields Sales report- Prime keeps advertising.
- Profit of \$13, 186.75 since Oct 1 2022.

Tournament Director:

- Tournaments are still moving forward. Trophies ordered, umpires ready.
- Hats that he will sell and give away to the champions. 16 teams in each tournament
- Nautical bowls has approached him about selling and taking a cut
- MYAS- reached out regarding us hosting a 14 or 15 state tournament. Would split the gate fee with us. They have a group of people who are doing all field maintenance and concessions. July 21-23. Need 7-8 fields.

House Fastpitch:

- Registration is open for another 10 days
- Friend requests much more painful this year. For example at 10U, 16 girls want to play together.
- Needs to replenish jerseys from last year with BSN

Sr. Travel Director:

- A few friend requests have come in. Some people have told him that if they don't play with friends they will not play.
- Uniforms have been ordered
- Registrations have slowed down.
- Might not have to have tryouts for 15U.
- 16-19 only has 4 kids. Once high school starts making cuts, he hopes to get more registrations.
- A few people have expressed interest in coaching
