The Grass Roots Coaches and Volunteers Initiative is designed involve more wrestling family members as volunteers in CA-USAW Local Association Tournaments.

To address that initiative, a \$20 waiver will be granted at every California USA State Championship, for coaches who volunteer at their local association. You can volunteer at these local tournaments as a referee, pairing person, table worker or even volunteer to conduct a clinic prior to the tournament.

Waivers will also be granted for National Team coaches etc., who volunteer their time at USA Wrestling National Championships. Otherwise, for every California USA State Championships a \$20 fee will be collected for every coach to receive their coaching band for access to the floor.

Please contact your local association director from the list below and ask them how you can volunteer. I am positive they will appreciate your help. Once you have completed your volunteer hours, the association director will inform the state office and your waiver will be applied to future California USA Wrestling State Championships.
