Treasurer - Kate Miani

- Need someone to review books, they've not been reviewed since February
 - Will meet with Jen on Tuesday
- Finished moving to Quickbooks online this month
- \$7000 CD has been cashed out and moved back into general bank account approximately August or September
- Vipers are no longer with VSC - officially with PA dominion
 - Still technically owe money to VSC
 - Still working on getting refunds from some cancelled tournaments
 - Once all refunds are resolved, they will have \$188.76 in their account
 - Motion to transfer funds to their team account with PA Dominion, *Andrew second, Motion Passes*
- Vortex has one family that has not paid- they are no longer part of the team
 - Balance of \$88.05
 - Going to see if the fundraisers help cover the amount, but if not, the club will cover the amount this one time, due to the extenuating circumstances this year
- Voltage owes over \$1000, but just received a check from them and they are still working on collecting from parents
- Valor also owes over \$1000, but does have fundraisers in the works
- Recommended to not allow teams to participate in winter or spring events until fall balances are paid
- Balance in general account is \$106,000
