 - o Troy welcomed folks to the meeting

- V. Old Business
 - o Concession Stand Troy Creurer
 - Troy will distribute formal language change to board. Board will review and vote on changes at the next meeting.
 - o House League Troy Creurer
 - Tabled for now until more information on the future of hockey in NYS and Canton is determined.
 - o Add coaching & locker room parent payment information to the handbook No update, review next meeting
- VI. 2020-2021 Registration Troy Creurer
 - o 2020-2021 registration has been created and can be sent out.
 - o Cub Club: Registration will direct registrants to the SLFSC site as SLFSC will run the learn-to-skate program this season.
 - Kids will still need to register with USA Hockey, it's free for that age. Troy to talk to Chrissy Martin about this.
 - o Registrations will be set up for all the Bear programs
 - Bear teams = 6U, 8U, 10U, 12U, 14U & 16U
 - Registration cost/team will be \$50 less than last season
 - If the season is cut short refunds will be provided.
 - o Registration for Blades Programs
 - 10U Blades Troy Creurer
 - Will open up registration
 - 12U Blades Troy Creurer
 - Troy will take all girls that have registered for tryouts

- If a State tournament were to happen then only the girls with the appropriate skill level would compete in the State tournament.
- The girls that aren't allowed to play on the state bound team would still practice with the team and would not play in state qualifying games or in the state tournament.
- Troy will add 12U Blades Travel team to the registration.
- 14U Blades Mandie Mousaw
 - Would prefer to have tryouts before rostering a team.
 - Will open up registration after tryouts
- o Registration for Steel Programs Kevin Logan
 - To remain closed until teams determine if tryouts will be needed.
 - Due to CV-19 restrictions and border travel restrictions the Steel teams have been removed from the HEO league for this upcoming season.
 - Steel teams = 9U, 11U, 12U & 14U.
 - 10U team is still unclear of a path forward.
 - Potential for 16U & 18U.

VII. Pavilion Update - Troy Creurer

- o Troy talked to Carol Pynchon (Village Trustee) and she believes there's no reason the Pavilion will not have ice even though the Rec Director has resigned. She recommends CMH proceed with registration and assume the Pavilion will have ice in the fall.
- Troy recommends all coaching staff begin registering for USA hockey and get coaching credentials updated for 2020-2021 season.
