I (Karin) am a downtown resident and worker. I walk to SPS Commerce every day, making my way through the DID service area on my way to the office. I see first-hand the impact our DID Ambassadors have greeting people, the way added greening helps change the dynamics of city blocks, and just how clean our streets are with the help of DID resources. That, along with the leadership provided and the work done in the areas of safety, outreach, and activation serves to engage the downtown community in so many ways. All of this work will be done with the goal of providing a welcoming, inclusive and fun downtown

Downtown Thursdays

On the third Thursday of each month, we partnered to produce Downtown Thursdays — which included additional activities and programming on Nicollet to add to the Nicollet Farmers + Makers Market experience that took place every Thursday throughout the summer. Downtown Thursdays featured additional craft markets, free giveaways, ready-to-eat food vendors, food trucks, MN Fringe Beyond the Box performances, music, dancers and more.



Street Eats

Created in partnership with the Northside Economic Opportunity Network, Nicollet Street Eats, a food cart incubator initiative, launched in 2022 with vendor Bougie Waffles to deliver more ready-to-eat food options for our street food scene and to add to the Nicollet Farmers + Makers Market experience.

Downtown Minneapolis Street Art Festival

The Downtown Minneapolis Street Art Festival, a collaboration between the DID and the Hennepin Theatre Trust, returned for its fourth year, featured its largest lineup to date, and welcomed over 11,000 visitors. This year's festival featured 19 largescale chalk installations, seven spray paint muralists, four artist-led activities, food trucks, a makers market, and a Bad Bad Hats concert on Nicollet.

Nicollet Activations



The Alley Project

The Alley Project, located on the 900 Hennepin Block, transformed an underutilized public space into a hub of creative engagement with students, neighbors and theater patrons. The alley, previously only used for deliveries, now features an immersive mural, tables and seating, greening, and has hosted over 300 hours of activation, including Hennepin Theatre Trust's 5 to 10 event series, students from the FAIR School for the Arts and the University of St. Thomas, and Alley Cats - a celebration for the opening night of CATS the Broadway Musical at the Orpheum Theatre.

Nicollet Office

This year, the Nicollet Office expanded its hours, launched Nicollet Tuesdays and saw an increase in visitorship. The Nicollet Office remained open throughout the winter with limited hours to continue offering services to the downtown communitys. Each Tuesday of the month featured additional programming, including: First Tuesday Socials, Learning Tuesdays, Service Tuesdays, and Wellness Tuesdays. With extended hours and increased programming, the Nicollet Office saw an increase in visitorship in 2022 with over 6,800 visitors resulting in 860 hours of service time.

Beyond the Box with MN Fringe

Developed in collaboration with MN Fringe, Beyond the Box returned for a third year of groundbreaking performances at Xcel Energy Plaza. Beyond the Box provides local artists and organizations with programming support to develop public performances in non-traditional spaces. 2022 featured three artist collaborations presenting six new performances at Xcel Energy Plaza, including:

Safety/ Livability

Operation Endeavor

The DID Safety Communications Center, Ambassadors and outreach groups played a role in Operation Endeavor, a 90-day initiative from the City of Minneapolis Office of Community Safety aimed to reduce violent crime in Minneapolis. Our partnership proved to be extremely effective in aiding tactical leaders by maximizing effectiveness and allowing them to better deploy law enforcement resources.

Outreach Groups

The DID partnered with MAD DADS street outreach workers, 21 Days of Peace, YouthLink street outreach workers, MPD/DID buyback officers and Police Reserves, and the Youth Coordinating Board's outreach team in efforts to provide resources and a more visible safety and outreach presence. We also continued our partnership with the Minneapolis Police Department, Hennepin County Sheriff's Office and Metro Transit Police for the return of the Joint Beats initiative.

Skyway Ambassadors

In 2022, the DID Ambassadors made the move from the streets to the skyway as part of a new initiative launched in October during Operation Endeavor. Due to the success of the pilot, Ambassadors will once again be placed in the skyways in 2023.

Downtown Safety Update Sessions

The DID continued its partnership with the Minneapolis Police Department's Office of Violence Prevention to facilitate free safety update sessions for employers, tenants and residents of the downtown community. These safety sessions cover the safety trends of downtown, provide prevention tips for various safety scenarios, and identify safety resources and initiatives throughout downtown.

Downtown Community Storage

The Downtown Community Storage program, a free storage program for those in downtown, celebrated a successful first year with full-time hours in our space in the basement of Ramp B.

Safety Communications

The DID's Safety Communications Center (SCC), located within the Minneapolis Police Department's 1st Precinct, continues to serve as the safety information hub for the District. Dispatch Ambassadors, who work in the Safety Communications Center 365 days a year and staffed 9,694 hours in 2022, respond to requests for Ambassadors on the street, communicate with outreach services for people in need, monitor public area cameras and collaborate with private security. The SCC also facilitates bi-weekly virtual safety meetings with downtown stakeholders to communicate downtown safety information and trends.



Roadway Completions

The DID played a role in the reconstruction of Hennepin Avenue and Fourth Street, both of which completed construction in 2022. The newly renovated Hennepin Avenue now features new roadways, pedestrian improvements, custom streetlights, and dedicated space for biking and scooting. Reconstruction of the remaining blocks of the 4th Street Project (2nd Avenue North to Hennepin Avenue) was also completed in 2022, and now features an improved pedestrian environment, two-way bike trail, freshly planted trees and new rain gardens.

MN GreenCorps and Climate Impact Corps

AmeriCorps awarded a Climate Impact Corps position to the DID for the first time and a MN GreenCorps position for the second time. Elijah Marriott, a Climate Impact Corps member, started his service with the DID in August and is working on supporting the downtown tree canopy, creating strong connections with the downtown neighborhood associations, and incorporating environmental justice and equity in greening. MN GreenCorps member Ella Graham entered her second year in her position with the DID and is working on analyzing street tree data to improve our maintenance practices, planning community outreach surrounding greening in downtown, implementing new greening events and initiatives, and celebrating community members and organizations contributing to a greener and more sustainable downtown.

Service Saturdays

The last Saturday of the month during the summer was Service Saturday in downtown Minneapolis. In partnership with the Downtown Minneapolis Neighborhood Association, volunteers gathered to perform simple and high-impact activities to make downtown greener and cleaner. Service Saturdays provided volunteer opportunities in downtown, created an environment to meet your neighbors and helped build a more connected downtown community.

DID Service Levels



The District is divided into two service levels: Premium and Standard. These areas were determined based upon the level of pedestrian activity and the resulting need for intensity of service to maintain a consistent standard. These service levels can be modified as needed to reflect any land use changes that result in changes to pedestrian activity patterns and intensity.

The Mpls Downtown Improvement District is funded primarily by downtown Minneapolis commercial property owners within the District.

Downtown Improvement District

At DID, we strive to be economically and environmentally sustainable. We have a limited quantity of our printed annual reports available, choosing instead to post our full report in PDF format on our website. The Mpls Downtown Improvement District (DID) is a business-led, 501c6 non-profit that leads and collaborates to create a clean, green, safe, and vibrant downtown by convening, developing solutions, activating and continuously improving existing programs.

DID is primarily funded by special service assessments authorized by a City of Minneapolis ordinance. By state statute, only commercial properties are required to pay the DID assessment, but, as all properties benefit from an improved public realm downtown, some non-profit, government and residential properties voluntarily contribute. More than 64 million square feet of Gross Building Area (GBA) are located within the 120 block boundaries of the DID. Properties are assessed for direct lineal services based on lineal frontage and for more globally benefiting services based on GBA. Charges are prorated to properties based on its location within the pedestrian service level area. This three-part method best reflects the volume of people needing service and the level of services delivered.

Vibrant and Safe Downtown is an organization that brings together the public and private sectors to make the heart of downtown safe and welcoming for those who live, work and visit here. In December 2004, the downtown business community approached city leadership to ask for efforts to increase downtown safety. As a result, Vibrant and Safe Downtown was formed by the Minneapolis Police Department. In July 2009, Vibrant and Safe Downtown became a subsidiary of the DID. The organization focuses on public safety through leveraging collaborative partnerships, technology, communication resources and strategic initiatives.

The Board of Directors is comprised of downtown property owners, employers, residents and leaders representing key constituencies and areas of expertise. The by-laws of the DID and the mpls downtown council require all of the same individuals to service on the boards of both organizations, establishing DID as a wholly controlled subsidiary of mdc. DID staff oversee vendors, develop programs advocate for the public realm, communication with stakeholders and administer the organization.
