

**BRIGHTON BULLDOG FOOTBALL AND CHEER WAIVER/RELEASE FOR
COMMUNICABLE DISEASES INCLUDING COVID-19**

ASSUMPTION OF RISK / WAIVER OF LIABILITY / INDEMNIFICATION AGREEMENT

In consideration of being allowed to participate in Brighton Bulldog Football and Cheer (BBFC) programs and related events and activities of BBFC, the undersigned acknowledges, appreciates, and agrees that:

1. Participation with BBFC includes possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules issued by the CDC, Dept of Health and personal discipline may reduce this risk, the risk of serious illness does exist; and,
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, including exposure to infectious disease, and assume full responsibility for my participation and that of my minor participant in BBFC programs, events, and activities; and,
3. I willingly agree to comply with the CDC guidelines, Dept. of Health regulations, BBFC rules, and customary terms and conditions for participation for myself and my minor participant in regards to protection against infectious diseases. If, however, I personally, or my minor participant experience/show any symptoms associated with any such communicable disease including but not limited to COVID-19 before or during my/our presence or participation, I will remove myself and/or my minor participant from participation and bring such to the attention of the officials associated with BBFC to alert BBFC of possible exposure; and,
4. I, for myself, my minor participants and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS BBFC ("Releasees") it's representatives and agents, along with other BBFC participants, sponsoring facilities, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the activities or events WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person due to infections disease, including but not limited to COVID-19, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
5. I agree to have my minor participant be screened by BBFC for infectious disease symptoms including COVID-19 prior to any BBFC events and activities, and failure to pass any screening will meaning my minor participant will not be able to participate until clearance by a medical professional. I further agree to not dispute the BBFC screening process and findings of any such screenings.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IF FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
