Coaches for the teams are as follows Bantams 2 per team, Peewee 2 per team, Squirts 3 per team, U12-2 per team and U10-2 per team. At this time only 2 coaches have been named Justin F. for Bantam and Chris Herzog for Peewee. Tryouts will be on the west rink this season and will be closed to spectators scheduled to begin on the 13th for all levels except squirts. Parent meeting will be at the same time as try-outs on the first

date for the levels. Skate sharpening was addressed with Steve S. at the four season, any issues bring them directly to Pat C. Whiteboards in the locker rooms were discussed with Steve S. and he has set the first of the year as a projection to replace. Sponsorships are still in progress has team sponsors 50 percent complete. Will be calling on businesses directly.
