## **Monthly reports:**

#### SRDC:

- A. Holidays hours and closures have been updated on SDRC website
- B. Permanent time change for open skate on Tuesday is now 645p-845p
- C. USA Swim meet March 6th-9th, 2019

## **Financial Report:**

- A. Updating Bank information with new president
  - a. Sharly Norton and Bernie Martin to sign new form for bank. It has been done, waiting for schedule a time to meet up at the bank.
- B. Change mailing address to PO Box

- B. The committee is working the Ty and TY to transition them out and change the bank account information.
  - 1. Brady and Patricia will be on the bank account
- C. Committee will meet once per quarter. The following is the tentative schedule as it lines up with their season (January, April, July and October). They will schedule more if needed.
  - 1. January's meeting- they will be focusing on coaches for next year
- D. U12 and U16 will both be playing in tournaments over Christmas

# **Grizzly Fundraiser:**

- A. 130 tickets sold. 50% paper tickets and 50% online
- B. Online was good, but wasn't aware of fees associated with flash seats
  - 1. Focus next year to discuss with Grizzly about either covering the fee or change ticket price to cover.

#### Jersey:

- A. Most are not happy with Harrow
  - Sizes are off. Bigger than expected
  - 2. Design is not set up right on the jerseys
- B. Sharly was approached by vendor, but she needs to do some additional research before suggestings
- C. Sharly Norton has the digital artwork

# Scorekeeping:

- A. Amending the contract with WIHOA. They do not have the compacity to have scorekeepers for each of our home games.
- B. Mark Summerhays will be our home score keeper for each home game he can cover to include the following age groups: U10, U12 and U14.
  - 1. Teams will need to supply a volunteer for home games he cannot do.

## Restructure of DCYHA Organization (Wind and Eagles):

- A. Discussion to restructure the organization to have DCYHA Board govern over two sub-committees Eagles (Travel) and Wind (Recreation).
  - 1. Roles and Responsibilities will be emailed to the board members prior to voting.
  - 2. Goal is to have a better relation between the Eagles and Wind for better player experience and development.

#### Goalie and Skills Clinic:

- A. This will be held once per month
- B. Need additional coaches to help with those sessions
- C. Derek Stell is a possibly option for skate clinic
- D. 12/13/18 clinic has the following coaches to help Steve Soto (Goalie) and Cody Bohin (skills). Each paid \$30
- E. Email reminders will be sent to players.

#### Iron Cup Update:

- A. Need to send sanction form with rules to Kathy Anderson. Their website said to Darla, so she has the check.
- B. No estimated time on when it will be approved
- C. Patrick will build a registration link once it has been approved
  - a. Need to make a code for home team so they are not charged
- D. Patrick has noticed limited interest from U14 teams.
- E. Discussion about Iron Cup Media Guide/Sponsorship
  - a. Working with local companies to donate. Idea for media guide is based on the donation amount The company coud get a half page in the media guide, full page and/or banner. Working on more details once the tournament is approved.

## Learn to Play:

- A. Bernie is speaking with Pure Hockey regarding cost for helmets (both skater and goalie) and sticks.
  - 1. Quote for helmets at 20 helmets is about \$38 per helmet
  - 2. Sticks Sherwood, basic Learn to play stick is \$19.99 but need to order a minimum of 12
  - 3. Need more research for goalie helmets. Also needs to be a minimum of 12.
    - a. Thoughts are to ask anyone in the organization if they would like to purchase and include them in the order to help with the number.
    - b. As an organization possibly needing minimum of 2 per age group.
    - c. Bernie will continue to research cost.
