VINYL BANNER (\$1,000 LEVEL SPONSOR ONLY)

- You must provide your document to actual size (36" H x 60" W) with the dimensions in inches, NOT feet.
- Offset your text and important graphics 2" from the edge to prevent a grommet from covering them.
- We accept the following file formats:
 - Adobe Illustrator (.ai), Encapsulated Postscript (.eps), or Adobe Acrobat (.pdf) files at final reproduction size
 - Photoshop (as .jpg or .psd) files at final reproduction size (full banner size) at a resolution of 72 dpi minimum
- **CCO Baseball must print the banners to comply with City of Cooper City banner rules**
