PUBLIC SPEAKING

- Kerr provided a document to the board on having a roster policy for program if they don't have a volunteer to coach for a team. Kerr said this has been an issue and has received email from parents on what's the next steps if they can't get a volunteer coach which we currently have no policy set in place. The board agreed that something needs to be put in place, but after discussion they asked Kerr to provide a document at the next meeting for them to review and to vote on. Kerr agreed and will provide a document at the next meeting.
