Motion by Eric Trudo, seconded by Travis/Zajac, to accept and approve the Treasurer's Report. The Treasurer's Report indicates a balance of \$24, 093.87 in checking, \$4227.93 in the yearbook account, and \$7500.00 in the scholarship account. The money is on deposit at Citizens First National Bank in Storm Lake. Motion carried.

Old Business:

Ed Thomas Awards—Presenting two plaques vs two certificates and a plaque? After a brief discussion, it was decided that the Iowa Football Coaches' Association would now begin to present two plaques to the Ed Thomas Award Winners (one for the recipient and one for the school).

Individual Membership—Non-football coaches paying for an IFCA Individual Membership for the complimentary Iowa, Iowa State, and UNI Football Tickets. Discussion took place in regard to this issue and the idea of having separate IFCA Membership Forms for High Schools, Colleges, Youth Teams, and Individuals. A second idea that was brought up was having the individual who is submitting the IFCA Membership Form list on the form where he coaches and what level he coaches at. No action was taken at this time, and we are going to monitor how the rest of this IFCA Membership year goes in regard to the IFCA Individual Memberships.

New Business:

Committee Report

Shrine Committee: 2022 will mark the 50th Anniversary of The Iowa High School Shrine Game. The 2022 Iowa High School Shrine Game will be held on Saturday July 23rd at the UNI-Dome in Cedar Falls. Some of the special events which are being planned to celebrate the 50th Anniversary of the game include having an "Honorary" Coach from every decade on the sidelines. Former Shrine Head Coaches Brian Wilken and Jerry Staton will be speaking at the 2022 Shrine Banquet. 2022 will also be the last year in which Jerry and Ellie Hoffman will serve as General Managers. IFCA Shrine Committee Chairman Ken Winkler and IFCA Executive Secretary Brian Wilken will come up with something "special" for Jerry and Ellie from the Iowa Football Coaches' Association recognizing them for all of their work and all they have done for the Iowa High School Shrine All-Star Football Game. This "special" gift will be presented to Jerry and Ellie at the Shrine Banquet. Shrine Media Days began this week in Sioux City and Spencer. The 2023 Shrine All-Star Game Head Coaches have also been chosen. Duane Schulte from Cedar Rapids Xavier will coach the north and Zach Sweeney will coach the south.

Assistant Coaches of the Year: Ok. IFCA Assistant Coaches Of The Year Committee Chairman Greg Schoon had to move a number of applicants around this year due to a number of schools switching classes. Coach Schoon also informed the IFCA Board Of Directors that he currently still has lots of qualified applicants in each class. Moving forward, all applications will be submitted on-line now.

Frank Broyles Award: The criteria for one to be nominated for this great award are....#1. Must be a State Football Semi-Finalist and #2. Must be nominated by the Head Coach. The IFCA Frank Broyles Award Committee has chosen the 3 finalists for this year's Frank Broyles Award. The three finalists are.....Jed Hemann from Waukon, Rick Roberts from Van Meter, and Mark Sovers from Solon. The winner of the Frank Broyles Award will be announced at the IFCA Awards Luncheon on Saturday, Clayton Harrell from the Frank Broyles Award will be in attendance at the IFCA Awards Luncheon on Saturday to help present the award to this year's recipient.

Hall of Fame: Currently we have 200+ registered for the IFCA Awards Luncheon. The annual Hall Of Fame Meeting will be held on Saturday morning.

Don Taft Memorial Jr. High Coaches Awards: Ok.

Coaches' Recognition For Years Of Service: We are caught up currently. IFCA Executive Secretary Brian Wilken will emailing the IFCA Coaches' Recognition For Years Of Service Form out to all Head Coaches in Mid-March.

IPSWA/IFCA All-State Selection: Nominations by coaches were up, but we still did not have enough nominations. The selection process is much better now that coaches in attendance get an opportunity to vote. The Iowa Print Sportswriters' Association and the Iowa Football Coaches' Association will be meeting this spring to evaluate and make changes to our All-State nomination and selection process. The Iowa Football Coaches' Association IFCA/IPSWA All-State Committee will be meeting prior to this meeting to prepare a list of items to bring to the Iowa Print Sportswriters. Some of the items that will be brought to the Iowa Print Sportswriters include the lack of media in attendance at the IPSWA/IFCA All-State Meeting, selecting just two teams, selecting our own teams, and an "unified" All-District Selection Process across the state.

Regional Coaches of the Year: Nominations were much better than the last few years. IFCA Regional Coach Of The Year Committee Chairman Marty Wadle would like to thank the IFCA Regional Coach Of The Year Committee for all of their work in selecting this year's recipients. The IFCA Regional Coach Of The Year Award Winners are listed on the attached IFCA Awards List. The IFCA Regional Coach Of The Year Awards will be presented on Saturday at the IFCA Awards Luncheon. Congratulations to all of the IFCA Regional Coach Of The Year recipients.

Ken Winkler Distinguished Service Awards: The IFCA Ken Winkler Distinguished Service Awards will be presented on Saturday at the IFCA Awards Luncheon. The recipients of these awards are listed on the attached IFCA Awards List.

Membership: Currently 162 out of 332 schools are members of the Iowa Football Coaches' Association which is 49%. 3 Colleges have joined the Iowa Football Coaches' Association (Iowa Central, Simpson, and Dordt) along with 6 individuals.

Ethics/Legislative Issues: Iowa Football Coaches' Association President Paul Patterson, Executive Secretary Brian Wilken, and Ethics/Legislative Issues Committee Chairman Lance Pedersen met with the Iowa High School Athletic Association on Monday January 17th, 2022 in Boone in regard to the reporting of schools/coaches who violate the coach-athlete contact rule and the consequences for the schools/coaches who are in violation. Please see the attached summary of this discussion. The second item which was discussed was that of colleges hosting Team Camps on High School Campuses and putting a checklist together for High Schools to follow when Colleges are going to conduct a Team Camp on their Campus. Please see an attached copy of the "Checklist" which was put together at this meeting.

IAHSAA Advisory: The IAHSAA Advisory Committee met via Zoom prior to the IAHSAA Football/Playoff Meeting. The IAHSAA Advisory Committee put together a list of items/proposals to take to the IAHSAA Football/Playoff Advisory Meeting which was held in Boone on Wednesday January 12th.

Academic All-State IFCA Academic All-State Committee Chairman Don Anderson asked the IFCA Board Of Directors their thoughts on looking into the possibility of having the Coaches print their own Academic All-State Certificates for their players who qualified and were selected as IFCA Academic All-State selections. Discussion followed. No action was taken at this time.

Recognition Of Playoff Qualifiers: Ok.

Public Relations/Marketing: We are going to "hold off" on opening the IFCA On-Line Store due to the lack of stock items in stock at Game One. Secondly, IFCA President and Public Relations/Marketing Committee Chairman Paul Patterson is hoping to bring back the IFCA Coach Of The Month here in the near future. Coach Patterson also wanted to thank Jared DeVries for securing the Hy-Vee and Roling Ford Sponsorships.

IFCA Scholarship: The Iowa Football Coaches' Association Scholarship Applications have been emailed out to all Head Football Coaches. Coaches are encouraged to inform their players of the IFCA Scholarship Program and have them submit applications ASAP. All IFCA Scholarship Applications need to be submitted on-line. Deadline for completing and submitting the applications is April 1st, 2022. The Iowa Football Coaches' Association will be awarding six IFCA Scholarships this spring (one \$500.00 scholarship, three \$1000.00 scholarships, and two \$2000.00 scholarships).

Rules: IFCA Rules Committee Chairman reported that it is now legal for the quarterback to throw the football out-of-bounds when outside of the tackle box (this rule is no longer an experimental rule). Secondly, the language of the "chop" block has changed. It now states/reads that when one player is blocking a defender above the waist on a double team/combo block a second player can not block the same defender below the waist (the previous language/rule was the knee); Lastly, the number "0" is now legal.

Many important rules issues have now become a part of the IAHSAA Football Advisory/Playoff Committee Meeting which is held each year.

IFCA Journal: Done. Great job to IFCA Journal Committee Chairman P.J. Hedrington on the publication of this year's IFCA Journal.

IFCA/ACE Fundraising Clinic: IFCA Clinic Committee Chairman Scott Heitland asked two things of the IFCA Board Of Directors:

#1) To keep their eyes and ears open this weekend to the ways that we can continue to make our Clinic better.

#2) To give some thought to the future of the IFCA/ACE Fundraising Clinic before the Iowa Football Coaches' Association Board Of Directors' Summer Meeting. Do we want an "in-person" clinic, virtual clinic, or other changes to the format of our clinic?

Playoff Hospitality: Ok. Bill is paid.

Yearbook Committee: The IFCA Yearbook is getting closer to going to publication. Currently, we are still missing 37 schools' information (please see attached list). Hadar (\$2000.00), Adrenaline Fundraising (\$1000.00), and Iowa Sports Supply (\$500.00) have all agreed to be sponsors of the IFCA Yearbook again. Thank you to all three of these businesses for their support of the Iowa Football Coaches' Association and the IFCA Yearbook.

State Coach of Year: The Iowa Football Coaches' Association State Coach Of The Year Trophies will be presented on Saturday at the IFCA Awards Luncheon. Please see the attached list for a list of this year's recipients.

Walt Fiegel Coaching For Character Award: The 2022 Walt Fiegel Coaching For Character plaque and check will be presented at the IFCA Awards Luncheon to Kevin Bowman from Maquoketa. The 2023 recipient will be Gary Swenson from West Des Moines Valley. Congratulations to Coach Bowman and Coach Swenson!

Ed Thomas Awards: The number of Iowa Football Coaches' Association Ed Thomas Faith, Family, And Football Award nominations were down this year in all classes and some nominations which were received were poorly done. All nominations have been emailed to the Ed Thomas Award Committee to rank from the best to the worst. IFCA Ed Thomas Award Committee Chairman Brian Wilken will get the plaques ordered and the presentations of this great award as soon as he receives all of the rankings back from the Ed Thomas Award Committee. Coach Wilken also invited and encouraged all of the Iowa Football Coaches' Association Board Of Directors to attend the IFCA Ed Thomas Award Presentations and help present the plaques to these outstanding young men. Lastly, discussion took place amongst the IFCA Board Of Directors that we must do a better job educating and promoting this great award to our membership. So many now do not know Coach Thomas, all that he stood for, and what his Aplington-Parkersburg Football Teams were noted for. It was suggested that we send a "bio" of Coach Thomas with the criteria and nomination form when we email it out to our Membership each year.

Youth Football: IFCA Youth Football Committee Chairman Scott Heitland was invited to attend the NFL Stakeholders' Meeting in Indianapolis. Scott will share information from the report that he received today with the Iowa Football Coaches' Association Board Of Directors at the IFCA Board Of Directors' Summer Meeting. Ed Passano (NFHS/NFL Liaison) has informed Coach Heitland that they would like to and want to continue the PSA Campaign that they have started.

IFCA Website: Ok.

Mentoring: Ok.

College Relations—Combine/Recruiting Book: The Iowa Football Coaches' Association Recruiting Book is completed and has been sent to 33 colleges. The cost of the IFCA Recruiting Book is \$150.00 which includes your IFCA Membership Dues. It was discussed that the IFCA Recruiting Book has been a very positive and a good thing for High School Football and we need to keep putting this book together each year.

The Iowa Football Coaches' Association's Combine is scheduled for Saturday, April 30th at The Mid-American Energy Company RecPlex in West Des Moines. IFCA Combine Committee Chairman Michael Kauzlarich informed the Iowa Football Coaches' Association Board Of Directors that he is going to need help on Saturday, April 30th. Max Out Sports is running the Combine. Promotions are being sent out through Social Media. Each player who registers and participates will receive an IFCA Combine shirt and will have his own "Player Card". Players will also have the option of buying a Combine Video if they so choose.

Scholarship Rule: Ok.

Other Business:

RPI Meeting—An RPI Meeting was held between members of the IAHSAA Staff and Head Football Coaches here in the State of Iowa. The purpose of the meeting was to look at possible changes/"tweaks" to the current RPI System. Two of the suggestions that came out of this meeting were to look at ways to balance the non-district schedules from team to team and posting each school's non-priority list.

IFCA/IAHSAA PSA Campaign—It is the hope of both Associations to begin this campaign in the fall.

IAHSAA Football/Ball Contract—We will know more about this in the next couple of weeks.

2022 National High School Athletic Coaches' Association Convention—The 2022 NHSACA Convention will be held in Altoona at Prairie Meadows Hotel And Casino on June 18th-June 23rd. The NHSACA is asking 4 things from us:

- #1) Promotion of the NHSACA Convention
- #2) Our help in securing speakers/arranging of speakers for this year's convention.
- #3) Help with the Iowa Night's Silent Auction. This would include reaching out to our Membership about their help in obtaining memorabilia for the Silent Auction
- #4) The Iowa Football Coaches' Association being a sponsor of the 2022 NHSACA Convention. IFCA Executive Secretary Brian Wilken asked the IFCA Board Of Directors for their attendance at the NHSACA Convention and for them to encourage other Head Football Coaches and their coaching staffs to attend.

IFCA President's Term And Purpose—IFCA President Paul Patterson asked the Iowa Football Coaches' Association Board Of Directors their thoughts on the IFCA President's Purpose/Term and extending the length of the President's Term. Discussion followed with no action taken. An email will be sent to the Alliance asking other states what the length of their President's Term currently is.

Discussion followed regarding the Iowa Football Coaches' Association having looked into this type of Insurance in the past. No action was taken at this time. IFCA Executive Secretary Brian Wilken will gather more information and report back to the Iowa Football Coaches' Association's Board Of Directors at the Summer Meeting in June.

A. Participation

- a. Social Media
 - How can we make a concentrated effort to have a Social Media blitz emphasizing the importance of football in a person's life and the community.
 - ii. Possibly getting Iowa and Iowa State involved with a PSA
 - iii. Use information from NFHS
 - iv. Donovan Group
 - v. It needs to appeal to
 - 1. Moms
 - 2. Dads
 - 3. Players
 - 4. Students
 - 5. Youth Coaches
 - 6. Community
- b. Youth Sports
 - Continue to improve relations with these coaches and the high school program
 - ii. Making sure they are keeping kids out for football
 - iii. Spotlight Poster

B. Process

- a. What is the process that the state would like to see violations reported?
 - i. We will develop a Flow chart so everyone is aware of the proper procedure to report a violation.
 - ii. IHSAA yields all of the power when it comes to handing out consequences
- b. What is the process for the investigation?
 - i. Once a report is made Todd Tharp will conduct an investigation.
 - 1. There is a different investigation between a filed report and an anonymous report.
- c. What is the process for handing down the consequences?
 - There is a set consequence in place, however it is up to the discretion of the IHSAA to determine the consequence. If a school cooperates the consequence could be lessened.

C. Enforcement

- a. Will this change moving forward?
 - i. We have asked for more consistency and more transparency
 - ii. Laying the hammer down now should deter those willing to knowingly break the the rules.
- b. How can we help?

i. We can best assist by making sure the coaches in our state know and understand the rules set forth by the state.

D. Consequences

- a. What are the consequences for each rule violation?
 - i. As above they are a case by case situation
- b. How do we ensure that they have meaning?
 - i. We encouraged suspensions for the violating coaches
- c. How do we ensure that they are consistently applied?
 - i. We have to trust the IHSAA
 - ii. We have asked that they be more transparent so we can better answer questions from our membership

E. Team Camps

- a. This is the most common violation to be reported
 - i. We are going to develop a draft and check list of what is required to have a legal team camp on your facility. I will send this out later in the week.
- b. How do we develop a reporting system that tells everyone that this is a legal camp? We hope to have this spreadsheet on our IFCA website of schools who have completed the checklist and can have a legal team camp on their campus.

F. Social Media Blitz

- a. A tweet on what is accepted on this date
 - i. Everyone likes this idea, also the state will consider a text message sent to the head coaches as well as their usual email. There will be more information available to the coaches than ever before. Lack of knowledge or ignorance of the rule will not be an acceptable excuse in the future.
- b. Ex. Tweet says on June 1 contact can be held any day up to August 8. Helmets may be worn coaches can coach all equipment can be used.
- c. Ex. August 8 First legal date of practice for week 1 teams, helmets can be worn, maximum of 4 hours of practice.

G. Ejections

There is discussion to make sure the player only serves one entire game There is also discussion that the coaches may have a similar or harsher consequence for being ejected from a contest.

H. Special Teams Play

a. Discussion of allowing players to play on specials team and not having this count against quarter limitation and game limitations


I. Transfer Rule

a. This is actually in the hands of the BOEE and the IHSAA follows what they are told to do.

J. Scholarship Rule

a. This is in effect again this year. We mentioned that we did not feel that this was fairly applied for one sport it could be half the season and for others a ¼ of the season. We asked for this to be a piercentage rather than days.

K. Other





In the past several years more and more schools are hosting padded team camps. These team camps on high school campuses have been an important part of the development for some football programs across the state of lowa. With the increase of these camps it is important that all member schools know and understand what is needed to legally have these camps at your facility.

In an attempt to help our fellow schools and football programs we have developed a checklist to determine if an on campus college team camp is legal.

	There must be a signed contract between the host school and the
	college or university running the camp
	The facility that is hosting the camp must charge the college a rental
•	fee
	All checks should be made payable to the college or university
	running the camp
	An insurance waiver should be signed by each participant and filed
	with the host school
	Players should be charged a rental fee for their equipment
	Waiver of Liability but each participant
	College or University must provide a document stating their
	insurance is responsible for the camp. (release the school from
	liability)
