## 2. Director's Report - March 2018

## **CHSAA Update**

Roaring Fork School District No. RE-1 approved parent funded Varsity & sub-Varsity ice hockey, through GSHS, for the 2018/2019 season.

GSYHA has shared our master contact list with the parent group, to help with their communication process regarding; costs, fundraising, general information, etc.

## **CDYHL/CCYHL Merger Update**

All 5 original CDYHL associations are mostly in support of a CCYHL/CDYHL merger.

## 3. Treasurer's Report

Jay has numbers. The CHSAA team is good news, but it cuts into our bottom line to lose the income from the Midget teams. We had 36 Midgets this year, which is more than in any other year in the past. We pulled in \$49,000 from Midgets, and that income went to ice time, ref costs, coaching expenses and tournament fees. Jay read through some number from past years' Midget figures and it looks like we will take a hit by losing the Midgets to GSHS. Consequently, we will be down on expenses, too.

We had a phenomenal amount of kids playing hockey this year and our numbers are up. We need to figure out life without the winter Midget program. TK pointed out that we do have the fall Midget league. We don't have answers to all of our questions regarding the Midget program and how it fits into GSYHA, while a CHSSA team (Varsity & JV) exists at GSHS.

Financially, the GSYHA is looking good. Time will tell: we still have some outstanding AR, plus a big ice bill to pay as well as salary, AND how we do on this concert will tell a lot.
