- 1. I/We (and our guests) will treat all players, coaches, parents, umpires, administrators and opponents with respect and dignity regardless of race, creed, color, sex, orientation or ability.
- 2. I/We will not encourage any behaviors or practices that would endanger the health and well being of the athletes.
- 3. I/We will inform the coach of any physical disability or ailment that may affect the safety of my child or the safety of others.
- 4. I/We will follow, and ensure our child follows, any health/safety measures identified by the coach or Stars.
- 5. I/We will remember that children participate to have fun and that the game is for the youth, not the adults.



- 6. I/We will never ridicule or yell at my child or other participants for making or losing a competition. All of my comments will be verbalized in a positive constructive manner, never emphasizing the negative.
- 7. I/We will teach my child to play by the rules and to resolve conflicts without resorting to hostility or violence.
- 8. I/We will never verbally or physically abuse a coach, umpire or player regardless of the situation. We understand that threats to coaches, Stars staff or board members can result in immediate expulsion from the Stars program with no refund of player's fees.
- 9. I/We will not tolerate unsportsmanlike conduct from my child or guests.
- 10. I/We will act in the best interest of the Stars while my child is a participant.
- 11. I/We will let the coach be the coach and will respect the coach's decisions whether we understand, like, or agree with them.
- 12.I/We will provide only supportive comments to coaches and players of both teams. We will avoid any derogatory comments. If we have concerns to bring to the coach's attention, we will apply the "24 Hour Rule" before having a respectful, private conversation.
- 13.I/We will refrain from coaching our child or other players during games and practices unless asked to help by one of the official coaches of the team.
- 14.I/We will remain in the spectator area, not enter the dugout or request my child leave the dugout during games or practices unless asked to by one of the official coaches of the team and will be in control of our emotions.
- 15.I/We understand that my child is a member of a "TEAM" and will make sure my child is at practice and at games on time and will contact the coach if my child is unable to attend practice or a game.

- 16.I/We will not make any purchases on behalf of the Stars without authorization.
- 17. I/We understand that coach/team assignments are at the discretion of the Stars Board. All payments/deposits are non refundable.
- 18. I/We understand that the Stars do not sponsor or are responsible for any out of town tournaments or related expenses.
- 19. Most importantly, we will always ensure that our child maintains his/her right to have fun.
