Article 7 – Fall Showcase/Tournament teams' modification (Laura)

#### **Tier I Committee (Mullally)**

Tier I Chair presented the following AHAI rule starting for the 2022/23 season

#### TIER 1 IN-STATE GAME PLAY

This rule applies to all AHAI approved Tier 1 affiliates and all levels of both girls and boys Tier 1 youth hockey affiliates.

For non-national bound birth years, all Tier 1 organizations must play each other one home and one away game per team per year. The games must be scheduled prior to December 15th of the current season and must be played prior to commencement of the AHAI Tier 1 State Round Robin games with February 1 as deadline.

Tournaments, showcases and league games are eligible.

Exception to the rule: if two clubs feel game play is not appropriate at a level(s) and the Hockey Directors of the clubs in question mutually agree in writing then the game(s) will not be required for that given season.

For national bound birth years, all Tier 1 organizations must play each other at least once per season prior to the commencement of the AHAI Tier

1 State Round Robin games February 1. The date and times shall be agreed to at the Spring Tier 1 committee meeting. For girls, same December 15 and February 1 deadline applies.

Failure to comply with this rule shall be reported to AHAI Board and brought in to AHAI R&E for suspensions and or disqualification in the state tournament.

For national bound birth years, all Tier 1 organizations must play each other at least once per season prior to the commencement of the AHAI Tier 1 State Round Robin games February 1. The date and times shall be agreed to at the Spring Tier 1 committee meeting
