



Parent Code of Conduct & Responsibilities

INTENT

Cochise Club Volleyball Corporation understands that parents have an enormous influence over their child's experiences in sports. Because of this influence, we ask our parents to commit to the following Code of Conduct:

GENERAL

We will assist our child in adhering to the Player Code of Conduct. We understand that if our child violates the policies in the Code of Conduct in any way, that they can be dismissed from Cochise Club Volleyball Corporation.

We will always model positive and responsible behavior and communicate with our child that we expect them to do the same. We will assume the responsibility for our child's conduct and attitude.

We will treat all individuals, and property, with dignity, courtesy, and respect, including but not limited to other players, coaches, parents, officials, volunteers, and all other individuals that are part of the club.

We will positively support our child's mastery of volleyball skills, strategy and self-development and will not react negatively to mistakes made on the court. This includes mistakes made by my child or other teammates.

We will emphasize the importance of values like sportsmanship, respect, cooperation, competition, and teamwork to our child, offering praise for fair play, participation, and skill development.

We will instill confidence in our child's ability and skill development, always avoiding comparisons with other players.

We will foster a positive, competitive environment and will not speak negatively about our child, another player, opponent or official.

We will not harass or intimidate the officials, including line judges and scorers.

We will place the emotional and physical well-being of our child ahead of our personal desire to win and will remember that this is for the youth, not the adult.

We will respect the coach and understand that the coach is responsible for the skill development of the athlete. My role as the parent will be to take a healthy interest in my child's progress and development and be responsible for my child's nutrition, rest, overall health, and moral and emotional support. We will allow the coach to do the coaching and will not interfere from the sidelines.

We will ensure our child is wearing the assigned uniform (jersey and black spandex or leggings for girls and black shorts for boys) at all exhibition and tournament play. We understand uniform bottoms (spandex) must be showing, front and back. If our child's jersey is too big / long and covers the players spandex, we understand our child must tuck in their jersey, front and back. We will ensure that our child wears a CCVC shirt to all practices. We will ensure that our child's overall appearance is respectable and appropriate when they attend any CCVC event.

We understand that playing time is not guaranteed and is left solely to the discretion of the coach. It is understood that we are paying for practice time and that my child may have limited playing time at tournaments.

We are expected to make all arrangements for our child's transportation to and from practices and tournaments. Coaches must wait for all players to be picked up before leaving. I will be financially responsible for the coaches' time after the activity is over. I will be afforded three late pickups for the season. Late is defined as 15 minutes after the activity is over. If I am later than 15 minutes on the fourth occasion, my child's account will be charged at a rate of \$10.00 per 15-minute increment. Exceptions will be made on a case-by-case basis.

We understand our child must be a certified scorekeeper and that they must go to a scorekeeping clinic yearly. We understand there are no exceptions to this requirement and that our child may not be able to play without completing this requirement.

I am encouraged to maintain an open line of communication with my child's coaching staff. If a concern arises, I will not approach a coach during a practice or tournament. Instead, a meeting with the coach should be requested before or after the next practice and will be requested no less than 24 hours after a tournament. A meeting with the coach should be attempted via email or text before addressing the Coaching Director or Executive Board. If the coach is unwilling to meet, the Coaching Director should be contacted as soon as possible to expedite the process. The proper conflict resolution order is contacting the coach for a meeting then the Coaching Director then the Club Director, if necessary.

We will meet our financial obligations with the club. CCV has a "no pay, no play" policy. If payments are not made on time, athletes will not be permitted to practice or play in tournaments until the account is made current. Coaches cannot accept payments. Members of the board can

collect payments. Payment schedules will be provided to us and will require our signatures to acknowledge payment schedules.

We are encouraged to be actively involved in our child's club experience, without interfering with the CCVC coach's efforts. If we would like to volunteer our time or resources, we must contact our child's coach. Appropriate USAV membership must be purchased for any parent helping as a chaperone or with any physical/coaching aspects of the club.

We will openly support and uphold this Code of Conduct policy. We will take actions and steps to ensure other Parents follow and uphold this code of conduct policy.

CONSEQUENCES

I understand that CCVC is holding me to a high standard. Therefore, I understand that my first warning is reading and signing this Parent Code of Conduct. I understand that my second warning will come at the Player/Parent Meeting with my specific coach and team.

Any violation of this Code of Conduct can result in the following:

Removal of my child from a Practice, Match, or Tournament by Coaching Staff Approval.

Suspension of my child from a Practice, Match, or Tournament by Board Approval.

Removal of my child from CCVC by Board Approval.

I acknowledge that all violations of this Code of Conduct will be reviewed for possible disciplinary action and/or dismissal from CCVC. I understand that decisions about disciplinary action/dismissal are reviewed and decided upon by the CCVC Board and that I can request a hearing by the Board. I will agree and adhere to their final decision.
