For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the undersigned intending to legally bound agrees to the following.

I understand that the purpose of this Agreement and Liability Release (this "Agreement") is to exempt, waive and relieve Pittsburgh Outlaws Baseball Inc. (Pittsburgh Outlaws Baseball). employees and volunteers from liability for personal injuries, property damage, and wrongful death, including without limitation, injuries and damages caused by negligence of misconduct, including without limitation, the negligence or misconduct of any or all of the Academy's Parties. Having read the outline and disclaimer, I fully understand the nature of Pittsburgh Outlaws Baseball team associations and I Understand that by signing this agreement, that Pittsburgh Outlaws Baseball are not held liable for any injuries that may result in connection with the above child's attendance or participation under the sports activity. I further agree and understand that if the Pittsburgh Outlaws Manager's or Coach's deems medical attention is necessary for the above-named child, I will be solely responsible for the payment of all costs incurred in connection with such medical attention.

To the best of my knowledge, the above-named child is physically fit and able to participate on a Pittsburgh Outlaws Baseball Team. I recognize that it is possible that such child's attendance at a Practice or Game or other baseball related activities could involve risks to the child including, but not limited to, **bodily injury, partial or total disability, death, and other damages**, known or unknown, and that I have full knowledge of aid risks. I acknowledge that these risks and dangers may be caused by the above-named child's own negligence or misconduct or the negligence of misconduct by others, including the Pittsburgh Outlaws Baseball Parties. These risks and dangers include, but are not limited to, risks and dangers arising from the use, handling, throwing and hitting of baseballs and the use and swinging of baseball bats and the use of any and all equipment used during Practice and Games or other baseball related activities by the above-named child and others. I further acknowledge that there may be risks and dangers described throughout this Agreement, the outline and the disclaimer, including those caused by the above-named child's negligence or misconduct and/or that of others, and those risks and dangers not known or reasonably foreseeable at this time, are included in the waiver, release and relinquishment discussed herein. Nonetheless, it is my desire for the above-named child to attend the Pittsburgh Outlaws Baseball and participate in Practices and Games and other baseball related activities.

I understand the nature of the Practices and Games, and I hereby grant permission for the above-named child to attend the Practices and Games and participate therein. On behalf of myself, and the above-named child, I hereby release the Pittsburgh Outlaws Baseball Parties from any and all claims, liabilities, losses, demands, suites, actions and proceedings, directly or indirectly arising from, out of, or related to the Pittsburgh Outlaws Practices and Games, including without limitation, any claim or cause of action (including any cause of action based on negligence) directly or indirectly arising from, out of or related to the performance, or failure to perform, maintenance, supervision, inspection or control of the premises utilized by the Pittsburgh Outlaws Baseball and for failure to warn of dangerous conditions existing at such premises, or for negligent supervision or instruction by the Pittsburgh Outlaws Baseball Parties. I acknowledge that I, on behalf of the above-named child and myself, am freely and expressly assuming and accepting any and all risks of property damage, personal injury and/or wrongful death.

The undersigned acknowledges and affirms that he or she has read the above carefully and fully understands the content and consequences of signing this Agreement, including the waiver of any and all claims, liabilities, demands, suits, actions or proceedings directly or indirectly arising from, out of, or related to the Pittsburgh Outlaws Games and Practices. The undersigned further acknowledges that he or she has not relied on any representations of the Pittsburgh Outlaws Baseball Parties, that the execution of this Agreement is a free act and deed and indicates voluntary acceptance of all terms set forth herein.
