



## AMATEUR REINSTATEMENT FORM

Application criteria:

- U.S. Soccer holds the players ITC
- Player was last registered as a professional
- Last professional match played, domestic or international, at least 31 days prior to amateur reinstatement request
- Player is no longer under contract with the professional club
- Registering club holds amateur status.

*\*If the player's last game played as a professional is **LESS THAN THIRTY-ONE (31) days** at time of application, request will **NOT** be processed as the player **DOES NOT QUALIFY** for amateur reinstatement.*

## SUBMISSION INSTRUCTIONS

- Submit electronically in **ONE** (1) email to - [psd@ussoccer.org](mailto:psd@ussoccer.org)
- Copy all required person(s) as outlined by local state registrar, club and league requirements
- Subject line must indicate - Clearance type being requested /Player Name/Club Name
  - Example - Amateur /John Smith/Kicks Club
- Submit all required documents (see above) PLUS the credit card authorization form
- Attach each document separately to the **ONE** (1) email
- All in PDF format and no larger than 5MB
- Application must contain current and accurate information
- Applications must be submitted a minimum of 30 days prior to start of club/team/league play

*NOTE - Submitting at least 30 days prior to the start of club/team/league play does not guarantee the player will be eligible as process times vary based on clearance type requesting.*

## STATUS UPDATES

The Player Status Department will contact applicants to provide updates on applications when available and/or as required throughout the process. Player Status will not respond to emails which solely request a status update of submitted application due to the high volume of applications received.
