

COVID-19 REGISTRATION FEE REFUND POLICY

Following the guidance established by the State of MN, MN Hockey, USA Hockey and District 6, the Shakopee Youth Hockey Association is currently planning to have a hockey season in 2020-21, despite the significant uncertainty that still exists with regards to the ongoing COVID-19 pandemic. As a result, the Association is already incurring certain costs that are fixed in nature. Therefore, if the season is cancelled prior to starting, the entire fundraising fee, any late fees, as well as a small portion of your regular registration fees (estimated to be 5%) will not be refunded. If the season is cancelled or temporarily stopped after it has started, the Association will calculate a refund amount based on costs incurred by the Association. Any refunds will be calculated and distributed within 60 days of the official end of the season.

COVID-19 WAIVER

Shakopee Youth Hockey Association (SYHA) expects parents, together with their players, family members, and guests (collectively, Attendees) to comply during the season with all applicable laws and requirements that may be published from time-to-time regarding participation in youth sports and social interactions, including, without limitation, by Minnesota Department of Health (MDH), USA Hockey, Minnesota Hockey, SHYA and facilities where tryouts, games, practices, team activities or other SYHA events (collectively, Team Activities) are held. All Attendees of Team Activities are expected to maintain appropriate distance from others while attending such activities. Parents must notify their team manager if they, any player, any family member or their guest at a Team Activity is exposed to, tests positive for, or has symptoms of COVID-19 and, unless otherwise directed by SYHA, the person(s) testing positive, exposed or having symptoms and their respective family members must refrain from participating in Team Activities for the appropriate MDH recommended quarantine period.

Unless a cure is found, there is no way of completely eliminating the risk of COVID-19 infection. Participation in Team Activities are voluntary. Parent represents and agrees on behalf of himself/herself, his/her player and his/her family members and his/her guests, that: (i) they have reviewed all information and guidance they feel necessary to become informed regarding the risks of COVID-19 and how to limit exposure or risks associated therewith, and will continue to review updates to such information and guidance throughout the course of the season, (ii) before participating in any Team Activity, they will examine the various measures and precautions taken by SYHA, facilities, teams and others to mitigate risks of COVID-19 infection, (iii) by attending any Team Activity, such attendees, on each occasion, represent and warrant that they understand the measures and precautions taken to prevent COVID-19 infection and fully assume all risk associated with attending such Team Activity, and (iv) they waive, to the fullest extent of the law, any and all claims or causes of action, of any kind or nature, they or any one of them may have against the City of Shakopee (the City) or SHYA, or any of the City's or SYHA'S respective employees, directors, officers, volunteers or agents, arising out of or relating to any potential or actual exposure to, or contraction of, the COVID-19 virus while attending any Team Activity. The foregoing representations and agreement of Parent are in addition to, and not in lieu of, any other representations and agreements of Parent or others, as set forth in this registration or any agreement signed by Parent or Player in connection herewith, including, without limitation, any agreements entered into as part of player's registration with USA Hockey.
