

Southeast Soccer Club Player Agreement for 2020/21

I accept the position offered to me by Southeast Soccer Club (SSC). I understand that accepting a roster position on an SSC Team requires my agreement to the following:

PLAYER

- 1. I agree to support and to conduct myself in compliance with all SSC, CCSL, NPL, Tournament and Team policies, procedures and regulations.
- 2. I agree that attendance to all matches, practices and other team activities is mandatory. I agree to notify the team coach or managers in a timely manner when attendance is unavoidable. Here are the communication guidelines for the club:
- Players 12 years of age and under should work with a family member to communicate
- Players 13 & 14 years of age should start to gain independence with their communication
- Players 15 and older should be responsible for their own communication
- 3. SSC is a Nike sponsored club, I agree to wear SSC gear, clothing, and uniforms at SSC events. The club recognizes that during cold weather and heavy rain not all players will have proper SSC gear, but we encourage each player to do their best to wear the crest and a Nike Logo at any SSC event.
- 4. I understand that I cannot play in any sanctioned SSC soccer activity until the SSC Registration and Medical Release Form is completed, a copy of a legal proof of age is submitted to the club, this Player Agreement is signed and that fees are paid to date.
- 5. I understand that SSC wants me to support my town team as a developmental age player, but that SSC practice and games take priority.
- 6. I understand that as a high school age player that I cannot start to practice with my SSC team until my high school season is complete. Also, once with SSC, playing in a spring league for a town or high school affiliated with CJSA, CCSL, NPL or Regional League is not permitted. In the summer, I agree to only play for a summer league team, which has a direct affiliation to my town or high school.
- 7. I agree to participate solely in SSC events and programming. I will not attend any events, clinics, or programming hosted by another Premier or Elite club. SCC understand that town and high school events are acceptable and supported.
- 8. I agree to handle all social media with respect. Negative communication about my teammates, team, coach, club, and our opponents will have consequences (It is always best to wait 24 hours if you are posting something you wouldn't say in person). My social media communication can have serious repercussions for myself, my family, my town, my school, future employers and colleges.
- 9. I understand that my commitment is to participate in all team activities for the SSC year August 1st through June 30th.

PARENT(S)/GUARDIAN

- 1. I read and understand the items above to which my child has agreed. I agree with and will support my child's commitment to meeting these obligations.
- 2. I agree to remit the Player Fee according to the fee schedule provided by the team administration.
- 3. I understand that roster spots are limited. When my child accepts a position with SSC the team dues are due and payable in full immediately. Any payment schedules that may be offered by SSC are for my convenience only. If the family leaves the team for any reason during the seasonal year any unpaid dues shall be paid in full. I understand that SSC will not approve any transfer to another club until and unless financial obligation to SSC is fully satisfied. I also understand that refunds of dues will not be made for any reason.
- 4. I understand that my child cannot play in any sanctioned SSC soccer activity until the SSC Registration and Medical Release Form is completed, a copy of a legal proof of age is submitted to the club, this Parent Agreement is signed and that fees are paid to date.
- 5. I agree to conduct myself in a positive manner on the sidelines, support the team and the players from the sideline, but not coach from the parent sideline. I agree to support our SSC team positively and refrain from negative comments to the other team, their players, their coach, and their families. Please respect the officials and the difficult job they perform and please refrain from negative comments directed towards the referee. Please support the club in a positive manner. I understand that opinions and behavior deemed unacceptable by SSC may cause me to be removed from a game site or suspended from Club activities.
- 6. I agree to wait 24 hours after the conclusion of any SSC event to approach or communicate in detail to a coach. Families are more than welcome to reach out to a coach to set up a meeting. SSC players are encouraged to communicate at any time with the coach.
- 7. Please be positive on social media and keep social media correspondence respectful.
- 8. I agree to be responsible for all equipment or gear provided to my child by the club. I accept liability for any damage to equipment or gear caused by careless or negligent behavior by my child.
- 9. I agree that failure to abide by the Club rules and regulations and failure to support the mission of the Club may result in disciplinary action up to and including suspension from SSC.
- 10. I, the undersigned, have read, understand and agree to abide by the provisions of this agreement.
