Guest: Scott Siegfried, PhD, Associate Superintendent of Cherry Creek Schools is spearheading a program to get Boys volleyball sanctioned by CHSSA. Handbook passed out. 93 high schools want a boys volleyball program. 143 said they could take boys volleyball. Rural schools want boys volleyball. 41 4A & 5A schools in the metro area wanting boys volleyball. Funding by donations needs to be secured. Free uniforms, coaching, refs, travel. \$15,000 has been donated. \$5,000 donated by Scott Siegfried. Boys H.S. Assn will donate \$15,000. Wants \$10,000 from the RMR. - Safesport—underage coach was drinking with adult coaches at a non-sanction club team activity. The RMR has talked to the Club Director. RMR to investigate.
- ♦ Safesport—same club had an adult female coach "moon" a car of players while traveling to see the BYU men's match. RMR to investigate.
- A player's sister went into a restricted area during an RMR Power Event and made 911 calls. (Lakewood gym). RMR will tell parent the sister cannot attend anymore RMR events.

- A formal complaint was filed against a club director grabbing a coaches arm when shaking hands. They apologized. This was at Crossroads. Does the RMR have a responsibility to handle the complaint?
- ◆ A parent intends to sue a club for breach of contract. Emily is handling this.
