The meeting of the Massachusetts Hockey Board of Directors was held on Wednesday, September 6, 2023, at the Sheraton Needham Boston.

Meeting called to order by Stephen Palmacci at 7:06 PM.

1. PRESIDENT'S OPENING REMARKS

Steve Rizzo: Discussion regarding 8U Mite waiver. We did apply for a waiver for full ice after January 16, 2024 for 8yo only. We need to figure out how we would use it.

Goaltending Coordinator, Cam Earle: Hosting monthly organization calls and parent calls to let people know about resources available within Mass Hockey to develop goalies.











Tom McGrath: Locker monitors was a prominent discussion at nationals. Mass Hockey is considering hosting a National Tournament.

Chris Mayer: Legal counsel meeting next week.

11. RISK MANAGEMENT, OFFICIATING, REGISTRAR, COACHING

Risk Management- Steve Gear: Couldn't attend but sent a report.

- The USAH Liability, Player Participant Accident and molestation policy renewed 9/1/23, without delay. Premium continues to grow.
- A reminder these policies do not "auto renew" like an auto insurance would. Every year they expire and contract terms and premium are negotiated. Thus, the delay at times making the new term available
- I began releasing COI's or Certificate of Insurance when the portal was opened on 8/30/23. So far, I have generated close to 90 COI's
- Lots of last-minute Labor Day tournaments to review or issue COI's for but it's that time of year and to be expected. They all went off without any issues that I am aware of
- Some programs have reported push back and threats from rinks to cancel ice time. But I've been able to respond to these rapidly once I receive the information
- USAH was able to keep our affiliate/program retention (think of it as a deductible) at \$5,000 for both General Liability and Directors and Officers. This would be the portion each program would be responsible for in the event of a loss.
- To date I have had one injury reported to me and have notified USAH of such
- I ask each program that seeks a COI or Evidence of Insurance to please complete the COI request form in its **entirety** despite any instruction on the form otherwise. This allows me to be expedient and accurate with COI's as we utilize a 3rd party to generate these. Having to chase rink addresses, correct clauses or association codes etc. is just not possible given the volume. I do get push back from some people on having to complete it, but I hold the line in requiring it.



Officiating – Kevin Donovan: Portal issues with USA Hockey. Planning of referee clinics is well underway. Level 2, 3, and 4 is held virtually. Level 1 is in person. You can attend clinics from any affiliate.

Registrar - Peter - Issues with portal for rosters with USA Hockey but being worked.



Coaching - Paul Moore: Paul couldn't attend but shared message. Coaching clinics are posted online. Will have Bruins Symposium but dates to be determined.

If there are delays in safesport and background checks beyond 7-10 days they can reach out to Kevin and Fiona in the office for support.
