## A. Call to Order:

Motion: Bigalke, Olson seconded, to approve minutes of the 10/1/2022 Board 12U, 15U, PeeWee tryout meeting. Motion approved (Condon, Feldhaus abstained)

Just a note that the goalies posted in the peewee pools did not reflect the action of the board. Three goalies were in each pool
C. PeeWee parent concern

A family called expressing concern about their child and another child being in the same pool and possibly being on the same team. Concern about bullying between the two kids.

The Board discussed the issue and will make the coaches aware of the situation if they are on the same team.
D. Bantams

Skaters: 92 skater, 90 tryout, 1 non tryout, 1 injury hold
Goalies: 10 goalies, 8 tryout, 2 injury holds
6 teams: AA, A, B1, B2, B2, C
4 teams with 15 skaters, 2 teams with 16 skaters
3 injury holds (1 skater, 2 goalies)
Goalies: 4 teams with 2 goalies, 2 team with 1 goalie

Injury Holds:
Player 147 - A, B1, B2
Player 397 (Goalie) - B1, B2, B2
Player 101 (Goalie)-AA, A, B1

Motion: Tobias motioned, Olson seconded, to approve injury holds as presented. Upon vote, motion approved unanimously (13-0)

## Skaters:

BAA scope of team is up to 16 skaters, AA pick pool is 1-19, 3 or 4 players not picked for $A A$ team are locked on A team. Bantam A scope of the team is to skater 32. Bantam A pick pool is skater to 35. There is an injury hold at Bantam A. Bantam A coach will identify a skater to replace injury hold skater. Skaters not picked for Bantam A team are locked on Bantam B1 team. Bantam B1 scope of the team is to skater 47. Bantam B1 pick pool is to skater 49. Bantam B1 coach will need to identify a skater to replace an injury hold skater. Skaters not picked for B1 team will be locked on a B2 team. There are two Bantam B2 teams, B2 pick pool is to skater 79. Skaters not selected for a B2 team are on the Bantam C team.

Goalies:
4 teams with 2 goalies, 2 team with 1 goalie
Bantam AA pick pool is evaluated goalies 1 and 2 and the injury hold goalie. Based on goalie scores, Bantam AA coach must take 2 goalies. Bantam A team can take 1 or 2 goalies. Bantam A coach has to name an injury hold replacement. One of the top two evaluated goalies not selected by Bantam AA coach, is placed on the Bantam A team. Evaluated goalie \#3 is locked at B1 or higher. B1 team starts 2 goalies (\#3 and the injury hold). B1 can take 1 or 2 goalies. If B1 does not keep injury hold goalie, that goalie is placed on a B2 team. B2 teams goalie pick pool is evaluated goalies 4,5 , and 6 . One B2 team will start with 1 goalie, One B2 team will start with 2 goalies. Evaluated goalies 7 and 8 are locked on the Bantam C team.

Motion: Williams motioned, Olson seconded, to approve the Bantam pick pools and goalie pick pools as presented. Upon a vote the motion passed 13-0-1 (Marchese abstained).
