## **“#BECHAMPIONS” CONTEST RULES**

### **NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.**

The “Be Champions Ticket Giveaway” (the “Contest”) is a series of contests sponsored by United Soccer Leagues, LLC (“Sponsor”) and governed by these official rules (“Official Rules”). By participating in the Contest, each entrant agrees to abide by these Official Rules, including all eligibility requirements, and understands that the results of the Contest, as determined by Sponsor and its agents, are final in all respects. The Contest is subject to all federal, state and local laws and regulations and is void where prohibited by law.

### **ELIGIBILITY**

The Contest is open to legal residents of their continental United States where not prohibited by law, who are eighteen (18) years of age or older at the time of entry, and who have Internet access and a valid e-mail account prior to the beginning of the Contest Period. Sponsor has the right to verify the eligibility of each entrant.

### **CONTEST PERIODS**

The Contest Periods are the time during which submissions may be received. There are seven (7) Contest Periods, all of which begin on Monday, February 25, at such time as the Sponsor posts the BeChampions form on its website at <https://www.uslchampionship.com/bechampions> (the “USL Championship BeChampions Website”). The end date (“End Date”) of each Contest Period is set forth below:

Each Contest Period ends at 5:00 EST on its End Date. Sponsor reserves the right to extend or shorten any or all Contest Periods in its sole discretion.

**HOW TO ENTER.** You can enter the Contest by submitting a submission form and questionnaire (“Contest Entry”) on the USL Championship BeChampions website. Each Entrant may submit an unlimited number of entries. Entrants must fill out all required fields on the Contest Entry, including name, email, nominee name, related USL Championship team, and explanation of the nomination.

**WINNER SELECTION** The winner will be chosen by the following process. At the outset, ineligible or incomplete applicants will be disqualified. Sponsor will then, in its sole discretion,

select the most compelling nomination.

The winner will be notified on or about the first Monday of the month following the month of the Contest Period End Date. Notification and instructions for collecting the prize will be sent to the e-mail address supplied on the potential prize winner's entry form. Each entrant is responsible for monitoring his/her e-mail account for prize notification and receipt or other communications related to this Contest. If a potential prize winner cannot be reached by Sponsor within three days using the contact information provided at the time of entry, or if the prize is returned as undeliverable, that potential prize winner shall forfeit the prize.
