1.0 Discussion points

Registration – Jason requested that the registration be open sooner and it was decided that registration would be opened November 1st 2023 for the 2024 season. Bill would like to go by birth years, for the year that person was born in for determination level of play. Cost and age ranges were reviewed. Traveling 2013- 2006, \$250.00

Academy 2014-2015 \$150.00

Little Feat 2019-2016 \$75.00

Tiny Feat 2020 and 2021 \$45.00

Split payments would be available.

Yard signs are being considered for Registration and will obtain cost for these and time frame in which they will be used. Could be an option for each board member to be accountable for 2 signs each. Cost is approx. @35.00 per sig.

It was discussed that U10 may have an option to travel, has to be for girls and boys and have try outs if this were to occur.

Volunteer Hours – 2 hours for Academy and 4 hours for Traveling no hours required for Tiny Feat or Little Feat. This is a new requirement. Hours are per family. If multiple players. Only one slot of time required. Buy out for hours \$200.00 for 4 hours and \$100.00 for 2 hours (equals \$50.00 per hour)

Fundraising - Each player to sell 5 cards – This is a new requirement. This would be to sell Pappa Murphy's cards 2024 season.

Sponsorship letter will plan to go out to businesses December 1st.

Concessions are being considered for Tiny Feat and Little Feat nights by the board.

Scholarships – There is currently no formal process for scholarships within the club. For any players on scholarship, they must complete their hours and remain in good standing with the club for ongoing scholarships. Bill reported for the 2023 season we had 17 traveling scholarships and 1 academy scholarship. Jason asked that the club have a subcommittee for scholarships for 2024 ongoing. Kira will obtain a scholarship application for an example for the board to review.

Jason will get username and information for social media from former board member. Jason will ask David to establish Cash App for the club given player's have requested this as a payment source.

Gina – Varsity girls need a complex key – she will reach out to city regarding access to facilities.

Jason to touch base with Brita on upcoming season aspirations.

Jason to touch base with Paul P as to when the next complex meeting is.

Leslie will request 2023 income and expense detail from David with profit and loss year to date and submit back to board by 09/30/2023.
