➢ Be it resolved that the Board establishes a committee of the Board to be known as the Governance Committee. The initial members of this committee shall be Nicholas Van Dyk (Chair), Cathy Wade, and Raj Puri. The Governance Committee shall have a mandate to review BC Minor Baseball's existing governance framework, review best practices for minor sport governance and solicit input from BCMB's members regarding governance concerns. Issues to be considered include, but are not limited to: the process for electing executives, the process for appointing committees of the Board, responsibilities of directors and executives, and any other issues which may arise and are relevant to the governance of the Society. Following this review, the Committee will propose revisions to BC Minor Baseball's rules, by-laws and constitution, where appropriate, in order to address any deficiencies identified from this process. Any proposed changes will be presented to the Board of BC Minor Baseball during its February 2019 Board meeting, to be held on February 5, with an approved package of revisions to be presented to membership for a vote at a special or general meeting of members, as required, in order to consider and, if appropriate, approve the changes. The target date for any general meeting of members would be by the end of February, 2019

An update on the financial status of the Society will be presented to members no later than by the end of February 2019.
