Parent and Player Club Contract

Player and Parent Financial Agreement for OKC HEAT Volleyball Club, LLC

do agree to commit financially to the OKC HEAT 15 RED (team name)
for OKC HEAT Volleyball CLUB 2022-2023 Season.

Player and Parent understand and agree to pay a \$700 deposit to OKC HEAT VOLLEYBALL CLUB upon acceptance of their team placement after tryouts to hold their roster spot for the 2022-2023 club season, of which \$700 will be applied to their total team fees for the season. Player and Parent also understand that the \$700 deposit is non-refundable should the player or parent change their mind and opt not to participate in the program. Player and Parent agree to pay monthly installments agreements below so that the player can participation in the 2022-2023 club season.

Player and Parent understand and agree to pay the total amount per player for team dues according to the team the player is assigned to.

Assigned Team: OKC HEAT 15 RED

Total Fees Due: \$2600.00

Parent and Player agree to pay the total fees due on time as laid out in this payment agreement. Player and Parent understand that all payments must be received by OKC HEAT Volleyball Club by and no later than the 1st of the month due be considered on time. Player and Parent understand there is a \$25.00 late fee for any and all monies collected after the agreed upon date.

Parent and Player understand that there are no refunds of any monies paid once a player accepts a spot on a team for any reason up to and inclusive of injury, mental health, family relocation, dismissal from program due to violation of OKC HEAT Volleyball Club Policies, JVA Policies, USAV Policies, OKRVA Policies, or AAU Volleyball Policies.

Parent and Player understand that monies paid to OKC HEAT Volleyball Club do not guarantee any particular amount of playing time, positions within a team lineup, leadership roles, or duties.

Player and Parent understand that monies being paid to participate in the 2022-23 season constitutes a commitment to OKC HEAT Volleyball Club as a whole and not one particular team. In rare events, some players may be moved to other teams for competition purposes. The Parent and Player agree that they are responsible for their signed and agreed upon team fees regardless of the team they compete on for any given event. OKC HEAT Volleyball Club will not seek further compensation if a player moves rosters at their discretion, however if the Parent or Player requests a team change that is in excess of their current fee agreement, they are responsible for the additional fees.

Parent and Player understands that all team fees are to be paid either online, cash or check made payable to OKC HEAT Volleyball Club.

Furthermore, Parent and Player agrees that OKC HEAT Volleyball Club is providing a service, rather than a product, and therefore waives the right to dispute any payment for services made via cash, check, credit, or debit card to OKC HEAT Volleyball Club.

Parent and Player understand that the following items are INCLUDED of their Team OKC HEAT Volleyball Club Fees:

- Uniforms/Sports Package
- Tournament Fees
- Coaching Fees
- Practice Court Fees
- Equipment Fees
- Administrative Fees
- Scorekeeping/Referee Clinic Fees
- Coaches Hotel Fees (if team is traveling)
- Coaches Flights, Coaches Uber/Lyft/Taxi, Coaches meals (if team is traveling)

Parents and Players understand that the following are NOT INCLUDED in their Volleyball Club Dues and are additional costs:

- Cost of Travel for players/parents to and from Practices and Tournaments (**Regional or National**)
- USAV and/or OKRVA Player Membership Fees
- Strength and Conditioning / Private Lessons / Positional Clinics

Parent and Player further agree to the following:

- USAV Medical Waiver and Release of Liability
- All Club Events including but not limited to the Player/Parent Meeting, all practices and tournaments, and all team meetings
- OKC HEAT Volleyball Player/Parent Guidelines & Policies

Player and Parent understand that by signing this contract, _____ (player name) is required to participate with the team listed above for the 2022-2023 Club Season beginning immediately upon signing. Player and Parent understand and agree that by signing this contract they cannot play or participate with any other club team or program from the date of this contract being signed through the conclusion of the season.
