Subject: Membership Registration Fee – Proposed Annual Inflation Adjustment

At a Special Meeting of the Members held on December 12, 2020, the Voting Members approved a motion that Voting Members would vote on any proposed **inflation increase** to Ontario Soccer's Membership Registration Fees. Annual adjustments would be voted on at the Annual Members Meeting (AMM) each year.

It was also agreed that Ontario Soccer will communicate, by early spring of each year, the inflation rate adjustment for the upcoming registration year.

The 2024 inflation rate is 2.4% (Bank of Canada), if approved at the 2025 AMM, the 2026 Outdoor and 2026-27 Indoor seasons Membership Registration Fees will increase as follows:
